

The following investigation was conducted by Special Agent (SA) JAMES R. BLANCHARD, II, and SA ANGIE FINLEY, Alcohol, Tobacco and Firearms (ATF), on April 21, 1995:

SA BLANCHARD and SA ANGIE FINLEY, ATF, talked with SA FINLEY's confidential source "CAROL". CAROL stated she believes in 1994, she saw an individual resembling the composite of UNSUB #1 in a white separatist paramilitary camp called "Elohm City" (phonetic) (EC). This camp is located around Stillwell, Oklahoma. CAROL knows this person as "PETE." CAROL has seen an individual named "TONY" resembling the composite of UNSUB #2. TONY is PETE's brother, and is not well liked at EC. TONY would do as his brother directed, however.

When CAROL saw the television pictures of TIMOTHY JAMES MCVEIGH, she said MCVEIGH doesn't look like "PETE." CAROL recalled that she did see a person who looked like MCVEIGH in a photograph in a photo album she saw at a 1994 Klan Rally.

CAROL began going to EC around June of 1994. She learned about EC when she called a racist hotline in May, 1994. CAROL met the hotline operator/owner DENNIS MEHAUN (phonetic) who would visit EC to engage in paramilitary training. CAROL began firearms training at EC.

CAROL learned that EC is operated by BOB LAMAR. EC's "Chaplain" is ZERA PATTERSON. EC's Security Officer is ANDY STRASMEYER, an illegal alien from Germany, who is a former West German Infantry Officer.

STRASMEYER speaks English fluently, but has a German accent. STRASMEYER has talked frequently about direct action against the U.S. Government. He is trained in weaponry and has discussed assassinations, bombings and mass shootings. STRASMEYER frequently talks about direct action against the U.S. Federal Government. CAROL has not seen PETE ever training at EC, but is friends with STRASMEYER.

CAROL has heard frequent anti-Federal government philosophy. CAROL described EC residents as being ultra-militant white separatists. Many of the younger members practice Odinism, the worship of the Norse God Odin. There is much required reading at the compound such as Mien Kamph, The Silent Brotherhood and The Turner Diaries. The Turner Diaries is a book which described the idea of driving a delivery truck loaded with explosives into the delivery area of a Federal building and detonating it at 9:30 a.m.



Many EC residents have sympathies to DAVID KORESH and even have a Branch Davidian flag hanging in the EC church. CAROL has heard a lot of discussion of hatred toward the U.S. Government for the WACO raid, and that EC could be the government's next victim. Although some EC members have suggested that they should strike the government first, CAROL has heard of no specific plans for vengeance.

EC receives funds from a Neurosurgeon, Dr. PETER LIPRON, who resides in Lawton, Oklahoma. LIPRON has associated with MEHAUN and various "militia" movements in Oklahoma. LIPRON has purchased communication equipment and medical supplies for EC.

MEHAUN has talked with CAROL about targeting federal installations for destruction through bombings, such as the IRS Building, the Tulsa Federal Building and the Oklahoma City Federal Building. MEHAUN has also discussed a plan for destroying power lines from Oklahoma City to Catousa, Oklahoma, during the hottest time of the summer. MEHAUN reasons this will create a panic, and without air conditioning, mass race riots would begin.

MEHAUN resides at 1448 N. College, Tulsa, Oklahoma. MEHAUN and STRASMEYER has taken three trips to Oklahoma City in November, 1994, December, 1994, and February, 1995. CAROL only accompanied the group once, in December, 1994. CAROL remembered visiting a church on the NW or NE 10th. They also visited the "Jesus is Lord" salvage yard on Northwest 10th operated by JOE CECIL.

EC has computer equipment, food, agricultural resources, two fishponds, reservoirs, livestock and weapons. CAROL said EC has 308 rifles, MAC 90s, mini-14s, and various fully automatic weapons. STRASMEYER once bragged about having an M-60 automatic machine gun, but later denied it.

April 18th is the anniversary of the WACO raid and April 19th is HITLER's birthday. CAROL said EC residents are very conscious of these dates.

CAROL attempted to use ATF equipment to make a consensually recorded telephone call to MEHAN on April 21, 1995, but was unsuccessful in reaching him. SA FINLEY supervised CAROL in these attempts.
