The following report is being filed by Bureau of Alcohol, Tobacco, and Firearms (ATF) Special Agent MARIO M. REYES, on April 24, 1995, in connection with the bombing of the federal building in Oklahoma City, Oklahoma, on April 19, 1995:

On April 24, 1995, INGRID MAE WILLMURTH, Cashier, STAR MART CONOCO GAS STATION, 1625 South Division Street, Guthrie, Oklahoma, was interviewed. Mrs. WILLMURTH resides at Guthrie, Oklahoma, telephone number date of birth

Mrs. WILLMURTH stated that she worked at the gas station on April 17 and 18, 1995, when she believes she made a gas sales transaction with TIM MC VEIGH. Mrs. WILLMURTH is not certain if she made the transaction either the early afternoon of the 17th or 18th. Mrs. WILLMURTH also believes that the gas sales transaction was done with a Visa credit card. Mrs. WILLMURTH stated that the sales transaction was possibly recorded on the store security camera.

Mrs. WILLMURTH stated that she observed three vehicles pull into the gas aisles, but only one vehicle actually obtained gas. She describes the vehicles as a Ryder truck, an old yellow or off-white car, and a brown Chevrolet pickup with a tarp covering the bed of the truck. Mrs. WILLMURTH described the subject paying for the gas as a White male, blond hair, slender, 5'9" to 5'10", crew cut, 20s years of age. She confirmed her description as TIM MC VEIGH. A second subject entered the store and utilized the rest room. Mrs. WILLMURTH believed the second subject as the composite of suspect #2, White male, black wavy hair combed back, possibly early 30s years of age.

Mrs. WILLMURTH made the connection of the suspects' composites with her sales transaction the day after the police published the composites. Mrs. WILLMURTH did not work Wednesday the 19th, Thursday the 20th, and Friday the 21st. Mrs. WILLMURTH

stated that Saturday and Sunday she attempted to review the video recordings of customer transactions on April 17th and 18th. Mrs. WILLMURTH reviewed the video tapes briefly, but did not study them to identify the aforementioned transaction.

On same date, KENNETH R. BRYAN, Owner, STAR MART CONOCO, released the two video tapes of transactions for April 17 and 18 to this reporting Agent. Mr. BRYAN also provided this reporting Agent a copy of all the credit card receipts for April 17 and 18, 1995.
