gm I, Jennifer Lynn McVeigh, do hereby make the following free and voluntary statement to Special Agents Dean G. Naum and Caryl L. Cid, who I know to be Special Agents of the Federal Bureau of Investigation (FBI). No threats, promises or rewards have been made to me:

I am 21 years of age, and I am completing my second year of college at Niagara County Community College (NCCC), Sanborn, New York.

On May 1, 1995, I previously provided a signed statement to Special Agents Naum and Cid concerning my knowledge regarding the bombing at Oklahoma City on April 19, 1995. I am aware that my brother, Timothy James McVeigh, has been arrested in connection with the aforementioned bombing. Although I stated then that I was providing a true and full statement regarding my knowledge of this bombing and of my interactions with my brother, I want to provide the following additional information in this statement:

I had failed to disclose certain information in the aforementioned signed statement of May 1, 1995 due to concern for my brother's welfare. Prior to the completion of my interview with the FBI on this same date, I informed the Agents that I had additional information which I was now prepared to provide. This information is as follows:

QW As previously stated, my brother had returned to the Lockport, New York area, subsequent to the death of our grandfather in October, 1994. He arrived sometime in late October or early November, 1994, and departed prior to Christmas, 1994. During the numerous times my brother and I had conversations, he related the following information which I believe impacts this ongoing investigation:

He informed me during the course of one of our conversations that he had, on a date and location unknown to me, narrowly avoided an accident while he was transporting a large quantity of explosives, which may have weighed as much as one thousand pounds. He related that while driving a vehicle, which I believe may have been the same gray Chevrolet that he was operating in the fall of 1994, he was almost involved in an accident with a large truck or tractor trailer. The incident centered around the need for a sudden stop in relation to a hill and traffic light; and I have a vague recollection that there may have been a second vehicle accompanying him, which may have been a pickup truck also carrying explosives. He did not relate the purpose for his involvement in the transportation of these explosives, nor did he inform me of the disposition of these explosives. I was not surprised by the information he was then providing to me, and I assumed that this was somehow connected to his political beliefs which he had discussed with me in the past. I concluded, based upon what I know about my brother's activities

and his beliefs, that it was possible that he was going to use the explosives as part of a plan. It would not have surprised me if a plan of that sort would have resulted in the loss of lives. For some reason unknown to me at this time, the expression, "casualties can and will be expected," sticks in my mind. Although I cannot directly attribute this statement to my brother, I may have been exposed to it during my political indoctrination by him.

I am neither aware of the source of these explosives, nor whether my brother, or persons associated with him, had prepared or manufactured them. Prior to this incident, I had not been aware of my brother's involvement with explosive devices. I have never received any instructions or training, by my brother or anyone else, concerning the use and/or manufacturing of explosives.

During that same period of time, I recall a separate incident which had taken place in my living room. My brother and I were together, when I noticed what appeared to be a photograph from a newspaper clipping. This photograph may have been laminated and was slightly larger than wallet size. I believe there was a caption beneath the photograph, however, I cannot recall any of this information. The individual in the photograph was a white male dressed in a suit and tie, in what appeared to be a posed stance. I recall that this individual appeared to be in his late 40's or early 50's, and may have not had a full head

M of hair. It is my belief that this individual could have possibly been a government employee or official. I believe the identity of this person was made known to me at this time, but I cannot recall his name. I also did not recognize the name of this person at the time I saw this photograph.

I asked my brother if I could see this photograph, and he walked over to show it to me. At that time, he warned me not to touch it, as he did not want my fingerprints to appear on this photograph. He further warned me that this was "evidence." I ignored his warnings and handled the photograph nevertheless. I returned the photograph to my brother; however, I do not recall what he did with it. I do not have any recollection whatsoever as to the identity of this person, or any other information relating to this incident. Based upon his actions and precautionary statements concerning this photo, it is my opinion that my brother may have been aware of or involved in a plan to harm this person.

I recall a third incident which related to information again provided to me by my brother during this same time period. On this occasion I had a conversation with my brother at the residence of my recently deceased grandfather. While visiting my father and me at Lockport, New York, my brother spent time at my grandfather's house for the purpose of taking care of my grandfather's personal possessions. The aforementioned conversation took place at or about the same time that we were

gm holding a garage sale at the residence. My brother and I had a conversation in the kitchen, as I believe there were other persons present at the residence in connection with the sale. At that time he advised me as follows:

He had been involved in a bank robbery but did not provide any further details concerning this robbery. He advised me that he had not actually participated in the robbery itself, but was somehow involved in the planning or setting up of this robbery. Although he did not identify the participants by name, he stated that "they" had committed the robbery. His purpose for relating this information to me was to request that I exchange some of my own money for what I recall to be approximately three (3) \$100 bills. He explained that this money was from the bank robbery and he wished to circulate this money through me. To the best of my recollection, I then gave my brother what I recall to be approximately \$300.00 of my personal cash, in exchange for three (3) \$100 bills, which I deposited within the next several days in an account at the Unit #1 Federal Credit Union, Lockport, New York. I cannot recall if this money was deposited into a checking or savings account. I do recall that the deposit amount was for more than what had been provided to me by my brother. I believe the total deposit may have been for approximately \$500.00.

I observed at that time that my brother had on his person an undetermined quantity of \$100 bills, of which he

gm provided me a small portion. I do not recall anything significant about the bills he provided to me. I cannot estimate the total amount or number of bills he had in his possession, but it is my recollection or opinion that these were all \$100 bills. He retained the rest of the bills and I do not know the ultimate disposition of those bills.

It was my belief that this bank robbery had occurred within the recent past. I was not made aware of any of the details, or if there were additional robberies involving my brother or any of his associates. I do recall that my brother remarked that the money he had in his possession represented his share of the bank robbery proceeds.

The next matter my brother discussed with me occurred during this same time period. I recall that I was at my residence with my brother when I saw what I would best describe as a very angry look on his face. I had never seen such a look before, and asked him what was wrong. He was extremely angry and upset and told me to leave him alone. I did not pursue this matter at that time. I would better categorize his level of anger as "fuming."

A day or so later, my brother asked me to help move a bed from our grandfather's house to my residence. I met him at our grandfather's house and at that time he explained to me the reason for his anger during the previously described incident. He then informed me as follows:

Q M An individual, who was not further identified, was to murder another unidentified individual; however, this murder had not been committed. He was angry that the murder had not taken place, and that the person who was to carry out the murder may have lost his nerve and only maced the intended victim in the face. I believe my brother was then trying to decide what to do about the individual who had failed to carry out these orders. I recall that prior to this revelation he had been awaiting a telephone call, and I now believe that this call was directly related to this murder plan. I do not know the identity of the person who was to call him. I do not know whether my brother received or placed a telephone call concerning this matter. Further, I do not know if this call had been received or placed from my grandfather's residence, telephone number (716) 434-8992, my residence telephone number (716) 625-9368, or from a pay telephone. The telephone call to which I am referring would have precipitated his anger.

As previously stated I am unaware of the identity of either the perpetrator or the intended victim. I recall my brother stated that the person who was to carry out this murder had the opportunity, but failed to act on the orders. It is my recollection and/or belief that my brother was awaiting a telephone call and that there was a plan in place to carry out this murder.

9M Based upon my knowledge and observations, specifically with respect to the above described incidents, I believe that my brother was more involved as a leader in his group rather than as a follower. I further describe my brother more as a decision maker, and seemingly in the center of all of his group's activities. My rationale for this thinking is the contact made with him concerning the outcome of the murder plan, the planning and sharing in the bank robbery which was committed by other persons, and the fact that he had told me he had passed the point of distributing propaganda and was now in what I believe to be the action stage of his activities. My assumption is that my brother was now taking some kind of action in support of his political beliefs. He indicated what seemed to be a deeper involvement that went beyond just reading and talking. I came to this assumption sometime during his visit in the fall of 1994. I further believe that this group may involve friends of his who possibly have a military connection. During this same time period my brother was still in contact with an individual I previously noted to be Mike, whom I now know to be from Arizona. I am aware that my brother and Mike had telephonic contact during the same period of time the above described incidents were taking place.

I also would like to note that my brother expressed dislike for Janet Reno, the Attorney General of the United States, because he believed that she was responsible for ordering 9M

JM the assault at Waco, Texas. He made comments regarding his feelings about Reno to me either when we saw her on television or during some other unsolicited conversation.

I have previously referred to shooting weapons with my brother in the fall of 1994. I stated at that time that this was basically target shooting. Upon further questioning concerning this matter, I have advised that my brother drew silhouette type targets on the boxes that we were firing at, as well as bull's eye targets. He did not instruct me to aim at any particular area which has been described to me during my interview as the killing zone.

I have also been asked about any aliases, false identification, or disguises that may have been used by my brother. I have previously informed the FBI that I am aware of one alias that he has used in the past, Tim Tuttle. I am not aware of any false identification he possessed, however, I am aware that he has used what I believe may have been disguises. I specifically recall a photograph that the FBI now possesses which was taken of him in what I would describe as "biker garb." When I asked him about his attire in this photograph, he stated that it was one of his disguises. I associated these disguises with part of his efforts to run from the government and conceal his true identity.

In addition to the above information, I would also like to add that I had affirmed in my prior statement that I had not

gm destroyed any document other than the one letter that I had described in detail. My statement had not been completely truthful at that time, and I now admit that I destroyed a second correspondence which I had received from my brother. The details concerning this are as follows:

Shortly before my departure from Lockport, New York to travel to Florida on spring vacation in April of 1995, I realized that I had in my possession a correspondence mailed to me by my brother. I had either failed to place this correspondence in the box that I had asked Rose Woods to keep for me while I was away, or I had received it after providing Rose Woods with this box of materials. In any event, I took this piece of correspondence with me to Florida. On the Friday after the Oklahoma City bombing, April 21, 1995, I was with my friend Dennis Sadler, who resides in Pensacola, Florida. Dennis and I had traveled to Mobile, Alabama, approximately one hour from his residence, to pick up his paycheck. I was driving my truck and was listening to an AM station, as I wanted to hear any updates on the Oklahoma City bombing. I had an eerie feeling that my brother may have been involved in this bombing. I then heard a news report identifying that my brother had been arrested in connection with this bombing. I became so upset and distraught that I had to ask Dennis to drive my truck.

We returned to his residence and I immediately went to retrieve the above described piece of correspondence. This gm

correspondence was not a letter, but was merely a ditto sheet of propaganda material and three (3) passages which were cut directly from the Turner Diaries. These clippings were highlighted, and although I cannot recall the specific entries, I can recall the following regarding the content of two of them:

One of the clippings reflected that "I am not the same man today as I was." The second clipping discussed how people had become so involved in their every day lives that they have been brainwashed by things such as television. I cannot recall the content of the third entry. I believe that upon review of the Turner Diaries I can perhaps identify the clippings that were then in my possession.

After retrieving the envelope, the dittos of propaganda material, and these three (3) clippings, I went into Dennis Sadler's garage and proceeded to burn all of these materials. I did this out of a sense of panic and in reaction to the news that my brother had been arrested in relation to this bombing. During that same time, Dennis came into the garage to notify me that my friend, Angela Butler, was on the telephone for me. Dennis inquired as to what I was doing, however, I cannot recall my response. I do recall that I was trying to locate a broom, and eventually the burned debris was swept out of the garage. I cannot recall the substance of what, if anything, I may have discussed with Dennis after the burning of these items. I can state from past recollections that I have not had political

discussions with Dennis and would describe him as one of my partying friends. My burning of these items took Dennis completely by surprise and his response was that he did not want to know the details and he wanted to be uninvolved. I may have told him I had burned something that I received from my brother. I do wish to state that Dennis did not have any involvement whatsoever in any of the events that involve my brother and myself. His only involvement was by happenstance wherein he came into the garage during the time I was burning these materials.


I would like to reiterate that I was not involved, nor did I facilitate in any manner, the bombing of the Federal Building in Oklahoma City. I was not aware that a plan was in place to carry out this bombing, nor was I aware of the role, if any, of my brother. I do not know the identities, partial or full, of any persons involved whatsoever in this bombing.

I have now provided a true and full statement regarding my knowledge of this bombing, and of my interactions with my brother. I am not concealing any evidence, documents, or other materials that could impact in this investigation. With the exception of not previously disclosing the facts as set forth in this statement, I have not committed any act that could be viewed as obstructing this investigation. I am not now concealing any facts that could directly impact this investigation.

QM I state that this is now a full, true, and correct statement, and that I do not have any additional information which I could relate to the FBI.


