RENEE COOPER, Date of birth April 9,1970, who resides at 7855 N.E. 10th Street, telephone number (405) 737-6376, was advised of the identity of the interviewing agent and the purpose of the interview. She furnished the following information.

MRS. COOPER advised she is employed as a Deputy Court Clerk, at the Oklahoma County Courthouse located near Park and Robert S. Kerr Streets. She stated she normally took her son, ANTONIO COOPER JR., to the day care facility located in the Murrah Federal Building on the mornings she went to work. COOPER advised her normal route to the Murrah building would take her past the Robinson Street side of the YMCA and she would enter the east side of the underground parking facility of the Murrah building. She would take ANTONIO JR. to the day care center, return to her carAND drive to a parking lot at fourth and Hudson, where she parked her car while she was at work.MRS COOPER stated she would usually arrive at the day care center at approximately 7:45 AM. It was her practice to visit ANTONIO at least once during the day, spending her lunch hour with him, and often visiting him during other times in the day when her schedule permitted. After her work day was over, she would usually pick up ANTONIO JR. at the day care center and drive home utilizing fourth street to leave downtown.

On April 19, 1995, she dropped ANTONIO JR. off at the day care facility at approximately 8:00 AM. She could not recall observing a yellow Ryder truck or a yellow Mercury automobile in the area of the Murrah Building. She recalls seeing a White Nissan Maxima parked at it's usual parking place on Fifth Street near Robinson. She stated this car was almost always parked in the same parking place when she drove by the Murrah building.

MRS. COOPER did recall one incident on either April 13 or 14, 1995. She and her mother, WANDA MC NEELY, were parking in the underground parking section of the Murrah Building in the afternoon to pick up ANTONIO JR. MRS. COOPER noticed two white males in the parking lot. She advised the two individuals appeared to be "on look out". As she and her mother walked by, the two individuals would not make eye contact with MRS. COOPER or her mother. She recalled one of the individuals had shaggy hair and possibly some facial hair. She believed one of the men had dark hair and the other had light hair, but could not provide any additional description, other than the individuals appeared out of place. She had not seen them before and did not see them after the above day.

MRS. COOPER also advised that she had been unaware the Bureau of Alcohol, Tobacco and Firearms, (ATF), had an office at the Murrah Building until April 18, 1995. On that day after she dropped ANTONIO JR. off at the day care facility, she was driving past the Federal Courthouse Building on the Harvey Street side. As she passed Fourth Street she observed two men standing on the sidewalk in front of the courthouse building, wearing dark jackets with the letters ATF in bold letters on the back.

Later the same day when she was walking to the Murrah Building to spend her lunch hour with ANTONIO JR., she observed at least two men wearing ATF jackets standing in the plaza area on the south side of the Murrah Building. MRS. COOPER stated that prior to that time, she and her husband ANTONIO, were not aware the ATF occupied office space in the Murrah Building.
