Dr. MICHAEL G. GELLES, Psy. D., Naval Criminal Investigative Service (NCIS), Washington Navy Yard, Washington, D. C., telephone (202) 433-9621, Special Agent (SA) LOU ANN SANDSTROM and Investigating Agent travelled to Cassville, Missouri for the purpose of interviewing witness NORA YOUNG under hypnosis. Mrs. YOUNG was a witness at MALONEY REAL ESTATE, Cassville, Missouri on November 2, 1994 when three individuals stopped at the real estate office inquiring about a remote parcel of real property. The individuals were identified, by witnesses at the real estate office, as TIMOTHY MCVEIGH, TERRY NICHOLS and ROBERT or BOB JACQUES. The interview was conducted at the Super 8 Motel, Cassville, Missouri.

Investigating Agent began the interview at approximately 2:36 p.m. by explaining to Mrs. YOUNG the video recording equipment that would be used to record the interview. After this was explained to MRS. YOUNG, DR. GELLES began by introducing himself and how the hypnotic procedure would be conducted. After gathering background information about MRS. YOUNG, DR. GELLES had MRS. YOUNG read aloud a form entitled "CONSENT FOR HYPNOSIS." After reading the form completely MRS. YOUNG was asked if she had any questions. She said she did not and signed the form at approximately 2:55 p.m. DR. GELLES then began his interview which included a period of time that MRS. YOUNG was in a hypnotic trance. At approximately 4:13 p.m., DR. GELLES began to bring MRS. YOUNG out of the hypnotic trance. At approximately 4:25 p.m. the interview was completed and the recording equipment was turned off.

New information obtained during the interview was the color, make, model and year of the vehicle as well as a partial license plate number in which the trio travelled to MALONEY REAL ESTATE. In addition the state from which the license plate was issued was obtained. MRS. YOUNG advised the vehicle was a cream colored 1977 Chevrolet Monte Carlo bearing an Arizona license plate. Mrs. YOUNG could not recall all of the letters and numbers of the license plate. She recalled the license plate included the letter A and numerals 103.

Major FRED H. BROWN, JR., Clinical Psychologist, United States Army John F. Kennedy Special Warfare Center and School, furnished the following information to U. S. Army CID Agent MICHALE MARTINEZ and the below named Special Agent:

BROWN provided the original psychological records of TIMOTHY JAMES MCVEIGH when he attended the Special Forces Assessment and Selection Center from April 5, 1991 to April 7, 1991. These records were provided by BROWN subsequent to being served with a subpoena.

BROWN advised that he does not personally recall MCVEIGH.

BROWN advised that on April 5, 1991, TIMOTHY JAMES MCVEIGH was administered psychological tests as all candidates attending the center are. He advised these tests consisted of the Wonderlic Personnel Test, Minnesota Multiphasic Personality Inventory, and Sacks Sentence Completion Test.

BROWN advised MCVEIGH left the Assessment and Selection Center shortly after the tests were administered, no further evaluation was done and the tests were filed away. He received a request on April 24, 1995 to do a synopsis of an evaluation of the psychological tests for MCVEIGH from the Commander of the Special Warfare Center and School which was done. He advised this is the reason his synopsis is dated April 24, 1995.
