1992 BY THE U. S. SECRET SERVICE CHARGING RICHARD LEE GUTHRIE WITH FRAUD - ILLEGAL USE OF A CREDIT CARD. THE FRANKLIN COUNTY SHERIFF'S OFFICE IN CARNESVILLE, GEORGIA, ISSUED AN ARREST WARRANT FOR BOTH GUTHRIE AND LANGAN, CHARGING THEM BOTH WITH ARMED ROBBERY IN 1992. BILLINGS, MONTANA. ACCORDING TO REPRESENTATIVES OF NCIC, THIS SPECIFIC VIN SHOULD HAVE A "U" INSTEAD OF A "V" AND A ZERO IS MISSING AT THE END OF THE VIN. THE NEW VIN SHOULD BE 1FMEU15N1LLB12020. THERE SHOULD BE 17 CHARACTERS IN THIS PARTICULAR VIN.
