FEDERAL BUREAU OF INVESTIGATION

PARTICK BERETTA BRILEY, 2409 Cypress Court, Edmond, Oklahoma 73013, was contacted by Inspector DAVE MERCER, Oklahoma City Police Department, and SA JAMES F. CARLILE, Federal Bureau of Investigation (FBI). Inspector MERCER identified himself and advised BRILEY that he wished to interview him concerning his complaint of being threatened by J.D. CASH of Idabel, Oklahoma. BRILEY thereafter provided the following information:

BRILEY stated he had not had any recent problems with CASH or been threatened by CASH recently, but that "people" call and say that CASH is saying things about him. BRILEY is not sure why his problems with CASH began, but believes it is because he has been looking into the Oklahoma City bombing. BRILEY stated he has worked with GLEN WILBURN, State Representative CHARLES KEY, reporters and others. BRILEY advised he has done a lot of work on this bombing investigation as a citizen investigator. BRILEY first became involved with J.D. CASH as he was investigating the involvement of GARY HUNT in the bombing. BRILEY believes GARY HUNT was involved because he looks like someone in front of the Federal Building on a video which he has copied from television news footage. BRILEY stated that GARY HUNT appeared on the MONTEL WILLIAMS Television Talk Show and praised the act of the bombing. BRILEY also believes there is a Middle Eastern person involved in the bombing. BRILEY took his video footage of the person he believes is GARY HUNT over to GLEN WILBURN's house. This was where he first became acquainted with J.D. CASH. WILBURN looked at the video and said it looked like it might be GARY HUNT and he gave the video to CASH.

This occurred in September of 1995 and BRILEY states he had a gentleman's agreement with WILBURN that BRILEY would be furnished whatever leads came out of this. CASH became more involved in the investigation of GARY HUNT at this time.

BRILEY was accompanied by BILL JASPER, a reporter for the "New American Magazine." They went to GLEN WILBURN's house to see GARY HUNT who was visiting there. There was a reporter

named ARNOLD, from the Dallas Morning News, there with CASH. WILBURN kept talking about the video tape footage that showed the two men outside the Federal Building, one of whom looked like GARY HUNT. WILMA REED, of the "defense team," called to CASH to see what to do about HUNT. BRILEY was concerned that if they had developed information about HUNT, it should be pursued. He asked WILBURN and CASH if they had called the FBI or Oklahoma State Bureau of Investigation (OSBI) to get pictures of HUNT.

BRILEY wanted to ask HUNT questions, but CASH got angry. CASH went over and stood between BRILEY and HUNT and said he was not going to let BRILEY question him. CASH "got in my face and tried to intimidate me" according to BRILEY. BRILEY asked HUNT what is his alibi for the date of the bombing and why was he there. HUNT stated that he was on the telephone with a JOHN STANDMEYER (Phonetic) at that time. HUNT also told BRILEY that he was in Oklahoma City to try and embarrass the government at the trial because they did not question him.

BRILEY stated that CASH and HUNT went to Elohim City, Oklahoma, and HUNT went at least one other time in addition to his trip with CASH.

WILMA REED called and talked to CASH a couple of times. All of this with GARY HUNT and WILMA REED occurred around the middle of October 1995. During this time, GLEN WILBURN was "squirring" HUNT around for the "defense team."

One thing that got CASH and WILBURN excited during HUNT's visit was a 33 minute telephone call that HUNT made from his hotel. WILBURN and CASH claim that this telephone call could only be made by a government agent. They did not elaborate as to why it could only be made by a government agent. CASH claimed to have gotten the information about the telephone call covertly and was very secretive as to how he got this information.

BRILEY believes that LARRY MEYERS of "Media Bypass" brought HUNT to Oklahoma City. BRILEY later talked to STANDMEYER (Phonetic) and he told BRILEY that HUNT's alibi at the time of bombing was "bogus." STANDMEYER also told him that HUNT asked him for an alibi.

BRILEY later talked to MARK KOERNKE and STANDMEYER on a three way call. BRILEY was concerned that this kind of activity by HUNT makes militias look bad.

CASH was very angry that BRILEY went on TOM VALENTINE's "Radio Free America" radio interview show. CASH said that HUNT was very angry about this also because of BRILEY's statements about HUNT. BRILEY went on this talk show and said that HUNT was bad for the image of militias.

BRILEY continued to dig for information about HUNT and around October 11, was supposed to go on VALENTINE's talk show again. CASH kept warning BRILEY not to go on the talk show and talk about HUNT. CASH got "nastier and nastier" in a meeting they had at WILBURN's house. CASH told BRILEY that if he talked about HUNT one more time, BRILEY was going to get killed. GLEN WILBURN then followed up to see if BRILEY was actually going to go on the radio show. WILBURN said that the people shown on BRILEY's video in front of the Federal Building were not actually HUNT and his accomplice, but were really maintenance workers from a nearby building. BRILEY tried to find out who the maintenance workers were. WILBURN was afraid that CASH would be angry at WILBURN for telling BRILEY this information. WILBURN said that he and CASH thought that BRILEY was wasting his time on GARY HUNT. BRILEY told WILBURN that he was going to keep working on HUNT.

When HUNT was in Oklahoma City, BRILEY asked if WILBURN and CASH made any pictures of HUNT to show how much he looks like the man on the video. Later, BRILEY walked in on CASH's girlfriend, MARY J. LITTLE, at WILBURN's house. LITTLE handed WILBURN a video which they proceeded to watch, although they did not know that BRILEY was observing. They had apparently taken HUNT to the North side of the Federal Building and, while pretending to be tourists, videotaped HUNT in that area. When WILBURN realized that BRILEY was observing, he was very upset and BRILEY left. About a week later, General PARTIN and CHARLES KEY were at WILBURN's house. BRILEY asked why didn't WILBURN show the video of GARY HUNT at the Federal Building. WILBURN got upset because BRILEY talked about it.

BRILEY asked WILBURN why he wanted him to drop his investigation of GARY HUNT and WILBURN said that BRILEY would be

killed. WILBURN lied to BRILEY about the tape and about not having the names of the maintenance workers.

WILBURN called and talked to BRILEY's wife at their residence. WILBURN wanted to know if BRILEY had been on the radio. WILBURN was concerning that BRILEY's comments on radio talk shows would hurt WILBURN's reputation.

CASH called BRILEY's residence and BRILEY's daughter answered. CASH was very vulgar. BRILEY's wife picked up the telephone and CASH told her that he was going to come over and get BRILEY. BRILEY's family became very upset and tried to call out for assistance, but somehow CASH had managed to block the telephone so they could not call out. BRILEY called his friend, REX BARRETT, of the Oklahoma City Police Department. BARRETT advised him to make an official complaint to the police. BRILEY called the police for assistance. CASH called again and said he was going to go over to BRILEY's house. He was again very vulgar. He threatened to go to the house and also threatened to talk to his wife's co-workers or supervisors at Dillard's Department Store at the Quail Springs Mall. He was going to use this against BRILEY because two of the women who work at Dillard's, DEE VOGLE and CHRISTY HERSLEY are married to FBI agents. CASH was going to tell them about BRILEY's efforts at investigating the bombing which he thought would cause problems for BRILEY's wife at work. He was threatening somehow to get her fired through this effort.

Several reporters have told BRILEY that CASH says he is crazy, paranoid and psychotic.

BRILEY stated that CASH is a correspondent for "Jubilee Magazine" in California, which is a white supremacist/anti-semitic magazine. CASH has an article in this magazine. Also, there is an ad on the back of a recent issue of this magazine for a conference where CASH, HOPPY HEIDELBERG, LOUIS BEAM (of the KKK) and GLEN WILBURN are mentioned as participants in a conference. HEIDELBERG told someone that CASH misrepresented this organization to him and that HEIDELBERG was not going to participate in the conference.

BRILEY contacted THOMAS E. HUNT of the Federal Protective Service Guards, who are in charge of security for the courthouse and were in charge of security for the Federal

Building. THOMAS HUNT advised BRILEY that he heard about GARY HUNT and his possible involvement in the bombing. THOMAS HUNT also heard that CASH tried to sneak JAMES NICHOLS in and out of the back of the Federal Courthouse in an inappropriate manner. BRILEY gave THOMAS HUNT a copy of the "Jubilee Magazine" article by CASH. THOMAS HUNT claimed to be very knowledgeable about militias and stated that he had provided security for LOUIS BEAM in a trial in the State of Texas. BRILEY showed HUNT pictures of HARVEY NORRIS and HORACE PAYNE, employees of Hogan Properties. These were the maintenance workers that the FBI claims are on his videotape. THOMAS HUNT told BRILEY that they do look like GARY HUNT and his accomplice and that the FBI had "bragged," they could find GARY HUNT anytime. When BRILEY interviewed NORRIS and PAYNE, they said that the FBI was very interested in getting them to initial pictures that show they were the individuals on the videotape.

BRILEY heard BILL JASPER and CHUCK ALLEN (producers of the video tape captioned "Oklahoma City; What Really Happened?," talked to CASH recently. CASH has gotten very nasty lately and tried to get them to back off on parts of the story.

Another reporter BRILEY has worked with is MICHELLE MOORE of Norman, Oklahoma. She works for BILL COOPER in Arizona, who is connected to militia groups. MOORE wanted BRILEY to wear a body recorder to talk to people and also to tape people on telephone calls he made.

SA CARLILE then identified himself as an FBI agent and proceeded to interview BRILEY concerning his impersonation of an FBI agent when he interviewed SHAWN HOGAN at Hogan Properties on December 13, 1995. BRILEY then adamantly and repeatedly denied that he had ever represented himself as being an FBI agent. He stated the personnel at Hogan Properties must have just assumed he worked with the FBI because he had pictures that the FBI had been showing around. BRILEY stated that when he first called for the interview with HOGAN, he spoke to someone in her office named BRENDA. BRILEY claims that he told BRENDA that he was a private investigator.

Inspector MERCER then advised BRILEY that since he was not a licensed private investigator, he could not represent himself in this manner either.

BRILEY claimed to have worked with the FBI in the past and said that he knew it was a serious matter to represent himself as an FBI agent and he would never do this. He claimed that he realized the misunderstanding with HOGAN before he left her office and explained to her that he was not an FBI agent. He also claimed to have told HOGAN that she could find out about him by calling DAN VOGLE of the FBI. He states that when he spoke with NORRIS and PAYNE, he asked them questions about what the FBI had done, but did not represent himself as an agent.

SA CARLILE and Inspector MERCER warned BRILEY of the seriousness of representing himself as an FBI agent and that it was a felony which carried a possible 3 year prison sentence. SA CARLILE then furnished BRILEY with a xerox copy of Title 18, United States Code, Section 912, which was highlighted in pertinent part.

On April 19, 1995, approximately one hour after the bombing, his wife was at work at Dillard's in the Quail Springs Mall. She was talking to her supervisor, CHRISTY HERSLEY, and to DEE VOGEL. Both are wives of FBI agents. BRILEY's wife told BRILEY that HERSLEY and VOGEL stated they were relieved that their husbands had not been at the A.P. MURRAH Federal Building. They also allegedly told BRILEY's wife that the FBI knew something was going to happen on April 19th. Two days later, CHRISTY HERSLEY came to BRILEY's wife and told her to keep her damned mouth shut.

BRILEY stated he had never talked to HOPPY HEIDLEBERG until after he had talked to SHAWN HOGAN. He stated that HEIDLEBERG had certainly not given him any instructions about contacting HOGAN. He learned about HOGAN Properties employees being identified as the individuals on the video through his own investigation.

BRILEY stated that HOPPY HEIDLEBERG has told him nothing about the Grand Jury investigation, except that he is very concerned about what is going on. BRILEY told HEIDLEBERG about his beliefs about the conspiracy and HEIDLEBERG stated that they might be related to the Federal Grand Jury investigation. HEIDLEBERG told BRILEY that he had been told by the U.S. Attorney's Office that if he talked to Reporter JAYNA DAVIS, then he was going to jail.

BRILEY stated that he learned that the maintenance workers, who had been identified by the FBI as being in the videotape, worked for Hogan Properties through a reporter. The reporter was JOHN RAPPAPORT. RAPPAPORT had gained this information from GLEN WILBURN, who knew but would not tell BRILEY.

BRILEY stated he has information regarding GARY HUNT being in Oklahoma City at the time of the bombing. He stated that RON WILLIAMS, who works at a TOTAL gas station at Sheridan and Western in Oklahoma City, told him a Ryder Rental Truck was there on April 18. BRILEY showed WILLIAMS a picture of GARY HUNT. WILLIAMS told BRILEY that he had seen GARY HUNT there every day for a week before the bombing and he was with an accomplice. BRILEY showed WILLIAMS the pictures that he had made from the videotape in front of the building and that WILLIAMS said that this looks very close to being the same as GARY HUNT.

At the Grand Continental Motel, near Interstate 35 and 36th Street in Oklahoma City, BRILEY located an employee named JAMES COLWELL. BRILEY showed COLWELL a picture of GARY HUNT. COLWELL stated that he had seen HUNT come through about every month or month and a half and stay at the motel. COLWELL told BRILEY he recalls that GARY HUNT was at the motel around the time of the bombing. He stated HUNT spends a lot of time in the bar when he is there.

At a nearby restaurant, LUCY's, BRILEY has found people who also identified HUNT. One of these people is MASSOUD (Phonetic), an Iranian who has talked to the FBI.

BRILEY has also learned that someone who looked like GARY HUNT came to the TOTAL gas station driving a gray van.

BRILEY has been in contact with DON STEWART from Portland, Oregon. STEWART made a copy of the videotape footage reflecting the two individuals, one of whom looks like GARY HUNT, from television. He furnished this to the FBI and claims the FBI edited out those two guys. STEWART also told BRILEY that in September of 1994, he was in Seattle at an "expo." At this expo, STEWART saw TIM MCVEIGH and another man whom he identified as HUNT's accomplice from the videotape in front of the Federal Building. He over heard MCVEIGH talking to the unnamed accomplice of GARY HUNT about blowing up Federal Buildings.

BRILEY stated that he suspects GARY HUNT may be an FBI informant.

BRILEY also advised that in his contacts with THOMAS HUNT of the Federal Protective Service, HUNT has indicated to him he is very concerned about not being warned about the impending bombing. He stated that HUNT told him that if some people were warned and others were not, then he wants to know about it.
