OTIS J. PHELPS, white/male, date of birth [REDACTED] was contacted at his residence located at [REDACTED] Muldrow, Oklahoma, telephone [REDACTED]. PHELPS was contacted to confirm information provided by JETTIE KEEN regarding the whereabouts of ANDREAS STRASSMEIR on April 19, 1995. After being advised of the nature of the interview and the identity of the interviewing Agent, PHELPS provided the following information:

On the date of the Oklahoma City bombing, April 19, 1995, PHELPS was visited by a friend of his from Fort Smith, Arkansas, who arrived around 10:30 a.m. to 11:00 a.m. PHELPS was unaware of the bombing until his friend arrived. PHELPS and his friend went to the Belfonte Community Center for lunch. A television was on at the community center and they watched the coverage of the bombing. After lunch they came back to PHELPS' residence. PHELPS recalls going over to the property of R.C. and JETTIE KEEN, who are his neighbors, around 1:00 p.m. There were two white males working on a fence row for the KEENS. PHELPS does not remember much about them and does not know their names, although JETTIE KEEN told him recently the one with the shortest hair was named ANDY. PHELPS does not recall telling the two men who were working on the KEEN's fence about the bombing, but is sure he would probably have mentioned it because it was big news.

PHELPS did not know the two men working on the KEEN's fence but stated one of them had what he would describe as a skinhead haircut. PHELPS does not recall too much about the two men, because he was mostly visiting with R.C. KEEN while the two men were working for KEEN. PHELPS furnished the following descriptions of the two men:

PHELPS stated that after that he began to notice the individual, he now knows to be named ANDY, going by his house frequently, driving toward the Arkansas line. He was driving an old flatbed Dodge truck that was yellow or orange in color. PHELPS would recognize him because of the skinhead haircut which, according to PHELPS, is not common in that area.

PHELPS stated that the one known as ANDY never did any work for PHELPS, but he does hire a man from Elohim City to cut wood for him in the winter.

PHELPS could furnish no additional information in this regard.
