SHAWN ANTHONY KENNY voluntarily appeared at the office of the Resident Agency, Federal Bureau of Investigation (FBI), and was advised of the identity of the interviewing agent, and the purpose of the interview. KENNY provided the following information:

He first recalled meeting MARK THOMAS during February, 1993 at THOMAS' "camp" which was located in Macungie, Pennsylvania. At the time, THOMAS was the leader of the Aryan Nation East, and was hosting a one day "skinhead" concert. KENNY originally learned of the concert through an advertisement in a "resistance" magazine, and was accompanied by his wife TABATHA KENNY and another white male identified only as "DAVE" last name unknown (LNU).

During the approximate five hour period of time that KENNY was present at the concert and subsequent cross burning, he spoke specifically with THOMAS about the "movement" and delivered a package to him from RICHARD GUTHRIE which contained materials to produce false identification. KENNY believed that he was acting as a go-between for GUTHRIE with THOMAS for credibility purposes, insofar as many in the "movement" did not trust GUTHRIE for fear that he was possibly a "Fed". KENNY was also present at the "camp" with THOMAS when GUTHRIE telephoned him. Both GUTHRIE and THOMAS spoke for a period of time, and appeared to be friendly with one another. Beyond the actual telephone conversation that he was a witness to, KENNY was unable to substantiate any further contacts between GUTHRIE and THOMAS.

KENNY'S only personal contact with THOMAS was limited to the one day during February, 1993, when he attended the concert in Macungie, Pennsylvania. Although KENNY was fully aware that THOMAS was heavily involved in the Christian Identity Movement, which he considered to be a radical militant group, he had no specific knowledge of any criminal activity that THOMAS was involved in. KENNY was also unaware of any current or former associates of THOMAS.

At the conclusion of the interview, KENNY was provided the opportunity to view photographs of KEVIN MCCARTHY and SCOTT STEDEFORD, but indicated that to his knowledge, he had never had any previous contacts with either subject depicted in the photographs. KENNY recalled no previous contacts with an individual identified as MICHAEL BRESCIA.
