What follows is a transcription of a consensually recorded telephone conversation between SHAWN KENNY and BOB BLACHA, to Mariposa, California, telephone number, (209) 966-3010, from Waco, Texas, on December 2, 1996, monitored by SA JOHN WIER, Waco, Texas Resident Agency and transcribed by SA Edward P. Woods:

"This is John Wier. Today's date is December 2, 1996 and we are about to place a telephone call to a Bob Blacha at area code (209) 966-3010. The call will be placed by Shawn Kenny and the time is 6:45 P.M.

Phone ringing

FEMALE: Hello.

SHAWN KENNY:

Is ah Bob there please?

FEMALE: Ah no he's not, he's actually working today.

KENNY: Oh, he is working. Ah ....

FEMALE: Yeah.

KENNY: Could you tell me a good time to call back?

FEMALE: Well, who am I speaking with?

KENNY: Ah, this is ah Shawn Kenny, uh he called me and I'm

returning his call.

FEMALE: Okay, he should be home probably within I say within a

couple of hours.

KENNY: Within a couple of hours?

FEMALE: Yeah, he left when I did early this morning so that's

about all I know and I'm not exactly sure where he

went.

Oh, okay. Yeah I would say if you know um to be safe FEMALE: around 8 o'clock.

KENNY: Appreciate it.

Yeah the telephone call concluded at 7:47 er 6:47. Today is December 2, 1996, the time is approximately 8:45 P.M. and Mr. Kenny is about to make another telephone call to the same number.

BOB BLACHA:

Hello?

SHAWN KENNY:

Is ah...

BLACHA: Hello.

KENNY: Hello, is ah Bob there please?

BLACHA: Yes, this is he.

KENNY: Ah yeah, this is ah Shawn Kenny, I'm uh returning your

call.

KENNY: Hey, I I'm feel bad here cause I can't place who you

are.

BLACHA: Oh yeah I'm the uh AN Coordinator for California.

KENNY: Okay, I've heard the name, okay.

BLACHA: Yeah, I think we talked a few years back and ah so

forth, yeah...

KENNY: Weren't you at Hayden Lake maybe at that time?

BLACHA: Uh, no actually I was out here and this was when um Tim

Bishop was just getting going.

KENNY: Uh, okay.

BLACHA: And he stayed up there for about 18 months or so and

then he was ousted by this idiot by the name of Jerry

Grudel, ah do you know about this situation or no?

Negative, there's so many people that come and go, I'm KENNY: kinda out of out of the loop for a little while myself.

Yeah, well uh this ah Grudel fellow, I mean he let a ah BLACHA: colored guy and a Jew onto the ah Congress ground and he has pretty much run the whole organization totally ah ah into the ground...

KENNY: Uh huh.

And, uh, I myself at at at the last Congress uh what BLACHA: happened was we had a meeting to go ahead and kind of make end runs this Grudel guy because I mean the guy's just a total idiot, he's...

KENNY: Well how's Pastor doing?

BLACHA: Pardon?

KENNY: How's Pastor doing?

Well, the thing is that Pastor, okay, ever since Betty BLACHA: died he's been you know pretty upset with his heart problems and everything.

KENNY: Yeah.

Ah, he you know hasn't really been up to snuff quite so BLACHA: much...

KENNY: Right.

Uh, have you ever heard of Sherry Seymour? BLACHA:

KENNY: No, no.

BLACHA: Well anyway she she is a gal who used to be a journalist up here in a Mariposa.

KENNY: Right.

And she uh went ahead and she started making all these BLACHA: maneuvers against me and all this kind of thing and asking, you know we just had we just had a meeting there at Congress and uh I didn't want to go ahead and give any names because I knew that, okay, ah, in terms. okay we we had a meeting, okay we had the meeting and we didn't like Grudel and and we (inaudible)..

KENNY: Is is ah, Louis Beam (inaudible) I thought he was ah gonna move up there (inaudible)

BLACHA: Oh, in fact, uh the the thing that that really irritates irritates about this is that ah Jerry Grudel he bought a computer um um system from Louis Beam.

KENNY: Right.

BLACHA: And even though he uh he let the nigger and the Jew reporter on you know ah, Grudel did, uh Beam said oh that's not too bad, I'm thinking well what do you mean it's not it's not a bad thing, you know.

KENNY: That's one guy that would never change.

BLACHA: Uh huh, right, no, this is kind of ridiculous and then um I start getting letters supposedly from Pastor Butler and then uh I noticed that none of them were actually signed by him they were all stamped with his name on it. And I thought hey what in the world is going on here and then I got one thing ah a fax supposedly from Pastor Butler kicking me out of Aryan Nations, and I just say I'm not I'm not accepting this at all. And then also, this ah Grudel guy had um Terry (inaudible) who is the chief of security supposedly kicked out AN and uh Terry wrote Pastor Butler uh a letter and says hey you can't kick me out of Aryan Nations because I'm an Aryan, you he said you can (inaudible) in the church if you want to.

KENNY: You can stop sending me the newsletter maybe but ...

BLACHA: Right, but, yeah..and that's ....

KENNY: (inaudible) white skin, huh?

BLACHA: Yeah, right, and so that's what I pretty much told them, I said hey ah I said Betty you know before Betty ah before she died she was the one who who sewed on my my rank emblems and all this kind of thing and so you can't take that away from me and I told the guys at headquarters that you guys can do whatever you want up there, but hey I am still major and I'm still the state coordinator for California and that's the way it is and you know of course they didn't like too very much and so um uh apparently you know I'm out of there particular loop and so forth but uh otherwise

everything's going pretty good because you know Bobby Norton although he was recently um you know about that thing with Southwell and the Southern Poverty Law Center, don't you?

KENNY: Uh, no like I said I've been kinda out of the loop for awhile.

BLACHA: Okay, yeah well apparently uh the Southern Poverty Law Center was sued by a the militia leader who had been stigmatized by um Morris Dees by saying that...

KENNY: (Inaudible)

BLACHA: Dees said oh yeah he went to all these AN meetings and he actually hadn't, and so ah Bobby Norton got you know he he got they took depositions and all that kind of thing from him and you know there there pretty much harassing him and all this sort of thing, but I mean he's he's still good man, he's still with it, it's just that ah he's been you know harassed..

KENNY: Right.

BLACHA: And so forth by this by this case here which is you know kind of undermining his capabilities and so forth, but he's he's still there and then of course Chuck Mangles out of um out of um Montana, he's the state leader, you know everything is going strong there um, ah what's his name uh Vince Reed, our aid ambassador, you know everybody on the field is going you know we're going fine.

KENNY: Right.

It's just that the you know Pastor Butler does not feel BLACHA: well anymore and he has a couple of guys who are absolutely jackasses up there who are totally screwing everything everything up and so forth.

KENNY: (Laughing)

BLACHA: And uh...

KENNY: Are they living in that little bunk house?

BLACHA: Pardon me?
