## FEDERAL BUREAU OF INVESTIGATION

[REDACTED] furnished the following information:

MARAZOFF advised during the early 1980s, she was living with a foster family in the vicinity of the residence occupied by MARK WILLIAM THOMAS, Walker Road, Longswamp Township, PA. It was at that time MARAZOFF became initially acquainted with THOMAS, his wife, TIPTON or TIPPY, and the three children, [REDACTED] now approximately 18 years of age, [REDACTED] now approximately 16 years of age, and [REDACTED] now approximately 13 years of age. MARAZOFF stated she subsequently lived at the THOMAS residence on three separate occasions. The first such occasion was for an approximate one-year period and MARAZOFF believes that was sometime during the period of 1985-1986. The second such occasion was for a period of one or two years and was in the latter part of the 1980s. The third such occasion was for a year or less and probably was in the 1993-1994, timeframe.

MARAZOFF confirmed she has had two children by THOMAS and identified them as [REDACTED] born [REDACTED] and [REDACTED] born during [REDACTED]. MARAZOFF stated her relationship with THOMAS for the last several years has been adversarial, however, THOMAS had visitation rights relative to the two children and this required periodic personal contact with THOMAS.

Concerning THOMAS' White Supremist Philosophies, MARAZOFF has never subscribed to such and on many occasions since meeting THOMAS in the early 1980s, she has ridiculed THOMAS relative to same, often causing THOMAS to become incensed with her criticism of his philosophic views.

MARAZOFF stated that probably during late 1994, or early 1995, THOMAS visited the residence at [REDACTED] which was occupied by MARAZOFF, a roommate by the name of [REDACTED], and the two children, [REDACTED] and [REDACTED]. THOMAS was at the residence to visit his two children. Sometime during that visit, the conversation between MARAZOFF and THOMAS became adversarial and MARAZOFF, once again, ridiculed THOMAS for his White Supremist Philosophies and idiotic rhetoric related thereto. THOMAS, as had occurred on many occasions in the past, became incensed with MARAZOFF's criticism. It was during this moment of intense anger when THOMAS made the remark, relative to the White Supremist Movement with which he was affiliated, to the effect: "We are going to get them. We are going to hit one of their buildings, a Federal building, during the day. That's when there will be the most casualties. They will know what it is to lose their loved ones, how it feels."

MARAZOFF stated the foregoing is probably not a verbatim recollection of THOMAS' angry exclamation, however, it is essentially correct. MARAZOFF advised she is certain that THOMAS said, "We," that his reference was to a Federal building, a bombing, and that it would occur during daytime hours. After making this exclamation, MARAZOFF recalls THOMAS stating, either verbatim or close thereto, "We are going to do it - you wait and see."

It was presented to MARAZOFF that THOMAS' use of the word "We," could have two meanings: First, it could mean that THOMAS and associates were planning the bombing of a Federal building; secondly, the use of the word "We" could have been a generalization referring to persons in the White Supremist Movement. MARAZOFF readily agreed with this proposition, however, stated it was her impression at the time THOMAS made the exclamation that he was referring to himself and associates.

MARAZOFF described THOMAS as an anti-social personality, very manipulative, but with no personal courage. Concerning any act of violence, MARAZOFF stated she does not believe THOMAS is capable of such, lacks the courage to undertake an act of violence, but he would manipulate others to do so.

MARAZOFF recalled that approximately a week or two before the bombing of the Federal building at Oklahoma City,

Oklahoma (OK), which occurred April 19, 1995, she was informed by THOMAS he would be out of town for a couple of weeks, thus would not be visiting the children. THOMAS indicated he was traveling to Elohim City, OK, and would be traveling with his son, [REDACTED] KEVIN MCCARTHY, and possibly others. MARAZOFF stated [REDACTED] THOMAS was then having problems at school and the trip to OK may have had something to do with this, either in whole or in part. Concerning KEVIN MCCARTHY, MARAZOFF had met and become acquainted with MCCARTHY and he was then in his late teens, a White Supremist and associate of THOMAS. On the day of the Oklahoma City bombing, MARAZOFF received a telephone call from THOMAS late that evening. THOMAS indicated he had returned shortly before on that day from the OK travel. THOMAS made absolutely no statement whatsoever relative to the bombing which occurred earlier on the same day.

MARAZOFF recalls only one occasion where THOMAS made any reference whatsoever to the Oklahoma City bombing. This occurred at a MCDONALDS RESTAURANT on Route 222, Trexlertown, PA, within several weeks following the bombing. The restaurant was the public site selected for THOMAS to visit with his two children. During the meeting, MARAZOFF made an unrecalled inquiry or reference to that bombing and THOMAS' only response was, "So what." MARAZOFF reiterated this was the only occasion that she can recall where THOMAS made any kind of remark or reference relative to the bombing. MARAZOFF stated she interrupted THOMAS' silence relative to the bombing at Oklahoma City as an effort to distance himself from that incident. During the months following the bombing when MARAZOFF would have contact with THOMAS, usually related to his visits with the children, he seemed both angry and consumed with the Protection from Abuse Order which MARAZOFF had secured relative to THOMAS and which forced THOMAS to get rid of all his guns for a one-year period. THOMAS, during those meetings, constantly complained about the court order and what MARAZOFF had done to him relative to the order.

Inquiry was made of MARAZOFF why she was now reporting to the FEDERAL BUREAU OF INVESTIGATION (FBI) THOMAS' remark relative to the bombing of a Federal building at a time two years following the Oklahoma City bombing. MARAZOFF was asked if her anger and bitterness relative to THOMAS, as well as the visitation rights which THOMAS secured and which MARAZOFF

despised, had anything to do with her now reporting THOMAS' earlier remark.

MARAZOFF responded she does not now harbor anger and bitterness towards THOMAS. MARAZOFF pointed out that THOMAS was arrested by the FBI several months ago, has pled guilty to bank robbery-related charges, and apparently will be going to prison for a long time. MARAZOFF stated she no longer has a hatred for THOMAS and just hopes he will be gone a long time. MARAZOFF stated she recently saw an article in a Reading, PA, newspaper wherein the possibility was stated that THOMAS might travel to Denver, Colorado, to testify on behalf of TIMOTHY MCVEIGH, accused Oklahoma City bomber. MARAZOFF observed that THOMAS is a sneaky and manipulative personality and it was unconscionable to MARAZOFF that THOMAS might try to aid MCVEIGH in securing an acquittal. MARAZOFF stated this was the reason for contacting the FBI, not her admitted past hatred for THOMAS, whom she again noted is now out of her life. Concerning the Oklahoma City bombing, MARAZOFF stated such was despicable and the persons responsible should be punished for all the deaths and injuries they caused.

MARAZOFF reiterated that the statement made by THOMAS prior to the Oklahoma City bombing and which referred to the bombing of a Federal building, did occur and it was her interpretation at the time THOMAS was referring to himself and associates, rather than a general or generic statement referring to others in the White Supremist Movement. MARAZOFF followed by stating that only THOMAS apparently knows precisely what he meant when the statement relative to the bombing of a Federal building was made.
