SUBJECT: FBI & OSBI MEETING WITH JOHN CASH ON APRIL 14, 1997

YESTERDAY FBI S/A RICK OJEDA AND OSBI AGENT CHRIS DILL MET WITH JOHN CASH AND BRUCE WILLINGHAM IN THE OFFICES OF THE MCCURTAIN COUNTY GAZETTE.

S/A OJEDA SAID THAT HIS ASSIGNMENT WAS TO BLUNT EFFORTS BY STEPHEN JONES TO DRAG DENNIS MAHON IN THE MCVEIGH TRIAL. (ONE OTHER FBI AGENT WAS WORKING WITH OJEDA ON THIS PREEMPTIVE STRIKE.)

OJEDA SAID TWO FBI AGENTS HAD BEEN ASSIGNED TO WORK ON THE SAME TASK RELATIVE TO ANDREAS STRASSMEIR, AND THREE HAD BEEN ASSIGNED TO WORK TO PREVENT YOU FROM DRAGGING CAROL HOWE INTO THE MCVEIGH TRIAL.

THE FBI WAS TRYING TO FIGURE OUT WHAT THE PROSECUTORS MIGHT BE HIT WITH DURING THE TRIAL.

AGENT OJEDA ASKED JOHN CASH IF CASH HAD TAPES WITH INCRIMINATING INFORMATION ON DENNIS MAHON. CASH REPLIED WITH VAGUE AND AMBIGUOUS RESPONSES.

THE AGENT VOLUNTEERED THERE IS SOMETHING TO THIS GUY, STRASSMEIR (IN THE SENSE THAT THE AGENT SUSPECTED JT, NOT THAT HE KNEW FOR A FACT).

(1) JOHN CASH WAS TOLD BY BRUCE WILLINGHAM LAST FRIDAY THAT A FEDERAL GRAND JURY IN MUSKOGEE WAS LOOKING AT DENNIS MAHON.
