He went on to describe that problem as being that he was being told by, uh, ATF officials who attend these shows that it was not acceptable for him to be selling anti-Clinton materials in his booth. He took the position that he could sell, that he paid for his booth and he could sell whatever he wanted to in that booth. At any rate, uh, he proceeded to ask if I would help him with this problem and he, then, later sent me a package of materials, including letters from the congressman and also from the, uh, director of the ATF, BATF, I think it is.

And, at this time, uh, I was advised, within days of receiving this package of materials from the Muellers, I was advised by his partner that he had disappeared. Uh, I had no idea that he would wind up at a place like this. But, he did and it was months later when their bodies were

discovered. Uh, Bill and his wife Nancy and her daughter were all discovered in this ISOUNDS LIKE bayou.

Okay. At the gun show, go ahead now and tell us the story about, that he was concerned about two particular individuals.

That is true. Not only the ATF had been there, but he asked me, and I asked him to kind of identify . . . ITECHNICALI

Uh, it's true. Bill was very concerned, not only because the ATF officials had been to him complaining about what he was selling in his booth, but he had also been, uh, had two other people come to his booth and he was very concerned about them. He had a little notebook that he kept the names in and he gave them to me and they were Andy Strasmeyer [SP?] and, uh, [SOUNDS LIKE] Brascia, who turned out to be very much hooked up in the, uh, Oklahoma City Bombing investigation and all that sort of thing.

His idea, his thought was, at the time, Bill's thought was that these people both worked with and for ATF. Now, whether that's true, I don't know. [NON-INTERVIEW DIALOGUE]

Uh, that's when I began talking to Bill and I interviewed him. I probably made, in fact, I made his picture.

Whereas, he sold mostly tapes and periodicals and, uh, books and things of that nature, uh, bumper stickers, things of that nature. And, so, he had, in fact, he had, at one time, sold guns, but he had gotten out of the gun business before I met him.

Uh, Bill's booth was different than most booths at the show, where they have, uh, guns, uh, all sorts of weapons and, uh, equipment, uh, ammunition and things of that nature. Uh, he didn't. And, it's true that a good portion of them, I'd say maybe a third of what was at his booth was anti-Clinton, but the rest of it was just kind of average.

And, it's true, that about a third of his booth, I'd estimate about a third, was what I would call anti-Clinton material.

told me about them, he just said, can you find out about these people? But, he hadn't given me their names. And I said, well, I might, if [STAMMERS] if you have taken down their names. It turned out, he did.

Nancy went and got a small notebook and I copied the names out of their small notebook and it was [STAMMERS] Strasmeyer and Brascia. They were extremely concerned because Bill had already been robbed. His place had been robbed once. And he was extremely concerned and he considered these, both of these people very dangerous.

Now tell us how he had been confronted by them, earlier that year, recently or something. He, that's what led him to write down their names.

His, his concern over Strasmeyer and Brascia was obviously related to the fact he had been robbed. And that was his interest and that's what he wanted to know, were they connected with ATF?

Did he tell you that had been at a Fort Smith show? Do, do you remember in detail he, that this, where this happened or when? Okay. Um, now let's do. Uh, in the fall of 1995, I was publishing a small, weekly paper and was doing a lot of investigating into things that I considered wrong in government. And a friend of mine, who had helped me on some of the stories had asked me to attend a gun show where he was, had a booth. He has a gun shop. I went to the show and he introduced me to what turned out to be his partner, Bill Mueller and Bill's wife, Nancy. And, after talking to them, I made their pictures and ISTAMMERS] I also interviewed them.

This was probably the last pictures, picture and interview that Bill and Nancy were ever involved in because very shortly after that they wound up, you know, victims here at Illinois Bayou. And I asked him, what did he mean, he disappeared? Bill was particularly concerned about two people who had come to his booth. This was after the ATF had come and told him to get that anti-Clinton stuff out of there. He was particularly concerned. These two men, he asked me to help him in connection with these two men as well as with his general problem. I asked him if he could identify him and he said, I wrote their names down. He had Nancy go find his little pad, writing pad, and sure enough, he did have them written down. Their names were Andy Strasmeyer and Michael Brascia.

He was particularly concerned because he had, he had already been robbed, he was paranoid about, just about general safety. And he figured, he, he'd figured that these people could do him harm and his family and he was worried to death about it. Uh, that's why he did proceed, talked to his congressman. He finally got a letter back from ATF. And he [STAMMERS] he sent me a package of a, a pretty good group of this, these things that he was working on. And, about, within days of receiving the package from the Muellers, they disappeared.

Incidentally, that was four years ago today that they had disappeared. And, of course, it was, uh, no reason, at that time, to believe that they were going to wind up here in the Illinois Bayou.

And he went on to point out that Bill was supposed to attend a show, one gun show while he attended one in South Arkansas. And Bill never showed up at that show. So, that was the period in which Bill turned up missing.

I, I think I heard from, about this in the media. I don't think, I was not directly connected, I had talked with the Sheriff's office up here. And, uh, I believe that I heard as, my recollection is I heard that in the media, that their bodies had been found.
