is currently incarcerated for his role in the bombing of the  
Federal Courthouse in Oklahoma City.

FBI. [REDACTED] Nichols has [REDACTED]  
information relating to the location of components for a large  
bomb. According to Nichols, the components were originally  
\* procured by Timothy McVeigh and another co-conspirator of the  
Oklahoma City bombing, an individual only known as [REDACTED]  
According to Nichols, [REDACTED] participated in the Oklahoma City  
bombing but was never arrested. Nichols believes that [REDACTED] is  
actually a Government agent who participated in the bombing on  
behalf of the Government. Nichols advised that the  
\*\*\* aforementioned bomb components were to be used by the group to  
bomb other Federal Courthouses after the Oklahoma City bombing.  
Nichols also indicated that [REDACTED] is aware  
\* of the existence and location of the aforementioned bomb  
components.
