Dear Mr. Trentadue:

On behalf of the Federal Bureau of Investigation and its Oklahoma City Field Office (collectively, "FBI"), I am enclosing records responsive to the Freedom of Information Act ("FOIA") requests that are the subject of the above-referenced civil action. As you are aware, the included records are the result of an additional search undertaken to comply with the Court's now-stayed Order of May 5, 2005.

On May 5, the Court ordered the FBI to conduct an additional search of certain, specific FBI files by means other than the FBI's ordinary computerized index search. As explained in the third and fourth declarations by David Hardy, Section Chief of the Record/Information Dissemination Section of the Records Management Division at FBI Headquarters, the FBI conducted this additional search, and the search returned 17 responsive documents. All 17 of these documents are being released to you, in full or in part.


The documents that are being released in part have been redacted under FOIA Exemptions 2, 6, 7(C), and 7(D). Where information has been redacted under an exemption or exemptions, the appropriate exemption or exemptions have been cited on the page. Please be advised that certain information that may be withheld by the FBI under Exemption 7(D) has been released to you as a matter of agency discretion; the FBI does not concede that Exemption 7(D) does not apply to that information.

In addition, please be advised that the FBI does not concede that the additional search is appropriate under FOIA law; thus, as you are aware, the FBI has moved the Court to reconsider its May 5 Order. Please also be advised that the FBI is releasing to you at this time as a matter of discretion, in the interest of resolving this litigation in good faith, documents over which the FBI asserts FOIA exemptions. As you know, the Court issued an Order on June 6, 2005, staying its May 5 Order and stating that the FBI need only produce, as they become available, "documents that are responsive to Plaintiff's FOIA requests (as interpreted by Defendants) *and to which Defendants do not assert any FOIA exemption.*" Although the FBI asserts FOIA exemptions over many of the 17 responsive documents, all 17 are being released to you.

There is no administrative appeal from these determinations; as referenced above, the enclosed records are already subject to your FOIA lawsuit.

NO INFORMATION RECEIVED AS YET AS TO THE EXTENT OF INJURIES TO EMPLOYEES OF OTHER FEDERAL AGENCIES BASED IN THE BUILDING; ALTHOUGH, DEATHS ARE ALMOST CERTAIN.

ALL OFFICES SHOULD EXERCISE HEIGHTENED SECURITY UNTIL FURTHER ADVISED.

THE BUREAU AND ALL FIELD OFFICES WILL BE KEPT ADVISED OF FURTHER PERTINENT DEVELOPMENTS AS THEY OCCUR.

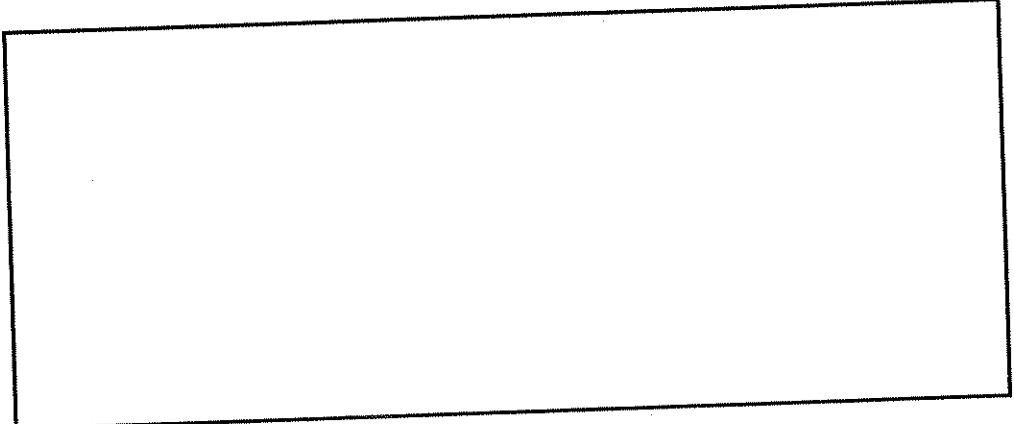

Details: [redacted] Southern Poverty Law Center (SPLC), Montgomery, Alabama, was telephonically contacted through a conference call established by Special Agent (SA) [redacted] who had previously interviewed [redacted] regarding information he had received from sources concerning [redacted]. It was explained [redacted] that additional information was needed in order to evaluate that which had been provided as well as to conduct further investigation. Thereafter, [redacted] advised as follows:

The sources developed by [redacted] are promised confidentiality and are not paid. There was more than one source used to gather the information furnished to SA [redacted] on December 20, 1995, regarding [redacted]. Some of the information came from routinely monitoring the Elohim City community in far eastern Oklahoma. The name [redacted] had been mentioned by several members of the press involved with the "patriot movement." Revenge was not a motive on the part of the sources furnishing information in this matter. Routinely, [redacted] receives information from people sympathetic to the SPLC ideals, as well as people concerned about the potential threats by radical groups and relevant events that happen in their communities.

DONNA MARAZOFF, [REDACTED], Pennsylvania, telephone number [REDACTED], telephonically contacted the Philadelphia Office of the FEDERAL BUREAU OF INVESTIGATION (FBI) and furnished the following information:

MARAZOFF advised that in approximately 1991, she lived with MARK THOMAS and had two children by him, MORIAH THOMAS, Date of Birth (DOB) October 14, 1991 and NICHOLAS MARAZOFF, born December, 1994. MARAZOFF stated that she had seen a recent newspaper article in a Reading, PA, newspaper which indicated that MARK THOMAS might be testifying in the Oklahoma City bombing case in Denver, Colorado. She indicated that the purpose of her telephone call was to advise the FBI of her knowledge of the bombing.

MARAZOFF recalls that sometime prior to February, 1995, MARK THOMAS was visiting her at her residence at [REDACTED], PA. The purpose of this visit was for him to visit with his two children, MORIAH and NICHOLAS. During the course of this visit, THOMAS began talking about the federal government and their involvement in "Waco" and "Ruby Ridge". THOMAS became very irritated as he continued to talk about these two incidents and during the course of the conversation, made the following statements:

"We are going to get them. We are going to hit one of their buildings during the middle of the day. It's going to be a federal building. We will get sympathy if we bomb the building." THOMAS made additional statements something to the effect, "That the people who will lose their loved ones, will realize how bad it feels."

MARAZOFF advised THOMAS at that time that she did not feel that this was the appropriate action to take and that innocent people should not be harmed because of some improper actions in the past by the federal government.

Details: On 6/10/97, Little Rock met with representatives of the Pope County Sheriff's Office (PCSO), Arkansas State Police (ASP), U.S. Forest Service (USFS), and the Bureau of Alcohol, Tobacco, and Firearms (ATF), regarding captioned matters.

Based upon information from a confidential source, approximately 200 members of the anti-government white supremacist group "The Supremacists" will converge upon a 14 acre compound and the surrounding Ozark National Forest to conduct paramilitary training exercises during the weekend of [redacted]. Most of the attendees are expected to bring their own weapons and equipment. Approximately 40 semi-automatic rifles are maintained at the compound on a constant basis. [redacted] reportedly allows the group to occupy his land. The group has conducted three major training sessions per year, and has held several smaller impromptu sessions involving 30 to 50 individuals throughout the year.

The source attended a previous training exercise at the compound on [redacted] and observed approximately 30 individuals who were armed with automatic rifles and who displayed white supremacy symbols to include the Aryan Nations (AN), Ku Klux Klan (KKK), Prisoners of War - Missing in Action (POW-MIA), Southern Confederacy, and the Neo-Nazi Party. During this training, source observed individuals believed to be [redacted] men surrounded [redacted] and accompanied them everywhere they went.

[redacted] ASP also reported information received from the Oklahoma State Police (OSP), that movement of Elohim City, Oklahoma, residents to and from the compound has increased during the past year. OSP is aware of flyers distributed during recent years which announced scheduled training held in Russellville, Arkansas. OSP advised that several residents of Elohim City had

traveled to Russellville during recent years, the purpose of which was unknown.
