Similarly, Exemption (b)(7)(C), 5 U.S.C. § 552 (b)(7)(C) exempts from disclosure: records or information compiled for law enforcement purposes, but only to the extent that the production of such law enforcement records or information could reasonably be expected to constitute an unwarranted invasion of personal privacy.

Before Exemption (b)(7)(C) can be invoked, the FBI must satisfy the Exemption (b)(7) threshold. Exemption (b)(7) protects from mandatory disclosure records or information compiled for law enforcement purposes, but only to the extent that disclosure could reasonably be expected to cause one of the harms enumerated in the subpart of the exemption. See 5 U.S.C. § 552(b)(7). Law enforcement agencies like the FBI must demonstrate that the records at issue are related to the enforcement of federal laws and that the enforcement activity is within the law enforcement duty of that agency.

The law enforcement duties of the FBI include upholding and enforcing the criminal laws of the United States. Here, the records in the underlying investigation involve federal crimes such as conspiracy to use a weapon of mass destruction (18 U.S.C. § 2332a), use of a weapon of mass destruction (18 U.S.C. §§ 2332a and 2(a) & 2(b)), destruction by explosive (18 U.S.C. § 844(f) and 2(a) & 2(b)), and first degree murder (18 U.S.C. §§ 1114, 1111 and 2(a) & 2(b), and 28 C.F.R. § 64.2(h)). Thus, the underlying investigation in this case falls within the federal law enforcement duties of the FBI, and therefore all of the investigative information that is responsive to plaintiff's request readily meets the threshold requirement of Exemption (b)(7).

Exemption (b)(6) has been asserted in conjunction with Exemption (b)(7)(C) to protect the names and identifying information of FBI Special Agents who are responsible for conducting, supervising, and/or maintaining the investigative activities reported in the criminal investigation United States v. Timothy James McVeigh and Terry Lynn Nichols. The FBI Special Agents who

investigated that case have privacy interests in avoiding publicity, adverse or otherwise, regarding any particular investigation that may seriously impair their effectiveness in conducting future investigations. Moreover, FBI Special Agents conduct official inquiries into violations of various criminal statutes, as well as counter-terrorism and national security investigations. They come into contact with all strata of society and conduct searches and make arrests, both of which result in reasonable, but nonetheless serious disturbances in the lives of individuals. It is possible for a person targeted by such law enforcement action to carry a grudge which may last for years, and to seek revenge on the Special Agents involved in the investigation. The publicity associated with the release of the identity of an FBI Special Agent in connection with a particular investigation could trigger hostility towards the Special Agent by such persons. Finally, privacy considerations protect FBI Special Agents from unnecessary, unofficial questioning as to the conduct of an investigation, whether or not they are currently employed by the FBI.

The FBI examined the names and/or identifying information of FBI Special Agents to determine whether there was any public interest that outweighs the substantial privacy interests in the responsive records. The FBI could not identify any discernible public interest. In particular, the FBI could not determine how the disclosure of the names and identifying information of the FBI Special Agents would shed any light on the operations and activities of the FBI. Thus, the FBI determined that the privacy interests of the Special Agents in protecting their names and identifying information from disclosure outweighed any public interest in disclosure, and that disclosure of the names and identifying information of the FBI Special Agents would constitute a clearly unwarranted and unwarranted invasion of personal privacy. Accordingly, the FBI has properly withheld this information pursuant to Exemptions (b)(6) and (b)(7)(C).

Before Exemption (b)(7)(C) can be invoked, the FBI must satisfy the Exemption (b)(7) threshold. Exemption (b)(7) protects from mandatory disclosure records or information compiled for law enforcement purposes, but only to the extent that disclosure could reasonably be expected to cause one of the harms enumerated in the subpart of the exemption. See 5 U.S.C. § 552(b)(7). Law enforcement agencies like the FBI must demonstrate that the records at issue are related to the enforcement of federal laws and that the enforcement activity is within the law enforcement duty of that agency.

The law enforcement duties of the FBI include upholding and enforcing the criminal laws of the United States. Here, the records in the underlying investigation involve federal crimes such as conspiracy to use a weapon of mass destruction (18 U.S.C. § 2332a), use of a weapon of mass destruction (18 U.S.C. §§ 2332a and 2(a) & 2(b)), destruction by explosive (18 U.S.C. § 844(f) and 2(a) & 2(b)), and first degree murder (18 U.S.C. §§ 1114, 1111 and 2(a) & 2(b), and 28 C.F.R. § 64.2(h)). Thus, the underlying investigation in this case falls within the federal law enforcement duties of the FBI, and therefore all of the investigative information that is responsive to plaintiff's request readily meets the threshold requirement of Exemption (b)(7).

Exemption (b)(6) has been asserted in conjunction with (b)(7)(C) to protect the name and/or identifying information concerning a third party who is of investigative interest to the FBI. Identifying information withheld includes their name, date of birth and known aliases. To release the identity of a third party listed as a subject of FBI interest could subject them to harassment, embarrassment and could cause undue public attention. Furthermore, disclosure of

their identity could threaten their physical safety. Accordingly, the FBI has determined that the individual maintains a substantial privacy interest in not having their identity disclosed. Thus, disclosure of this information would constitute a clearly unwarranted and unwarranted invasion of their personal privacy.

In light of the substantial privacy interests of a third party of investigative interest, the FBI examined the records at issue to determine whether there was any outweighing public interest. The FBI could not identify any discernible public interest. In particular, the FBI could not determine how the disclosure of the name, and/or identifying information of a third party of investigative interest would shed any light on the internal operations and activities of the FBI. Thus, the FBI determined that the privacy interests of a third party of investigative interest outweighed any public interest in disclosure, and that disclosure of their name and identifying information would constitute a clearly unwarranted and unwarranted invasion of their personal privacy. Accordingly, the FBI has properly withheld this information pursuant to Exemptions (b)(6) and (b)(7)(C).
