## DECLARATION OF EMANUEL (MANNY) JOHNSON, JR.

I, Emanuel Johnson, Jr. hereby declare that the information provided herein is based upon my personal knowledge:

(1) I served as a Special Agent of the Federal Bureau of Investigation (FBI) from January 15, 1973 until May 3, 1999;

(2) On April 20, 1995, the FBI opened a Command Post (CP), at the Washington Field Office (WFO), to handle all investigation related to the bombing of the Murrah Federal Building in Oklahoma City, Oklahoma, later code-named OKBOMB;

(3) I was assigned as the first shift Supervisory Special Agent (SSA) which was from 8 am until 4 pm on April 20, 1995;

(4) All investigation pertaining to OKBOMB was placed into "RAPID START";

(5) "RAPID START" was a computerized system that allowed for all leads to be assigned a number, the identity of the person conducting the lead and the subsequent results of the lead were also catalogued into "RAPID START";

(6) I have reviewed a redacted copy of a FD-302, [63-7], filed in this case on 8/18/10. A copy of that FD-302 is also attached to my declaration as Exhibit 1.

(7) A FD-302 is a document prepared by a FBI Special Agent on any matter that may be of a testimonial nature, according to FBI rules and regulations, during the pertinent

time period;

(8) This redacted copy of this FD-302, bears the markings 174A-OC-56120 SUB D – 2337 in the lower right corner;

(9) The number 174 is the numerical classification that the FBI assigns to the investigation of bombing matters;

(10) The alphabet A is the highest investigative priority within bombing matters;

(11) The letters OC is the FBI's abbreviation for the Oklahoma City, Oklahoma Division of the FBI;

(12) The number 56120 is the fifty-six thousandth, one hundred and twentieth bombing investigation within the Oklahoma City, Oklahoma Division of the FBI;

(13) The letters SUB identifies a division of the main file, 56120, within itself, for a specific purpose;

(14) The letter D is the identifier given to this particular divided file;

(15) The main file contains a listing of all sub-files and the specific purpose for which the SUB file was opened;

(15) The numbers 2337 is the two-thousandth, three hundred and thirty-seventh serial to be placed into SUB D;

(16) A serial is simply a paper document placed within a file;

(17) Serials are placed in ascending order;

(18) Serials may have their own particular identifier, such as FD-302.;

(19) Once a serial is originated, it is reviewed by the originator for accuracy, and then forwarded to the Supervisor for review, accuracy and compliance with rules and regulations;

(20) One specific requirement was that all serials be marked for indexing to facilitate future retrieval;

(21) A serial is marked for indexing by underlining the material to be indexed;

(22) If no indexing is necessary, a serial must be so marked;

(23) As part of the approval process, the Supervisor is responsible for insuring that a serial meets the FBI's regulations regarding indexing;

(24) FBI rules and regulations prohibit a serial from being "uploaded" (entered) into its Automated Case System (ACS) or Electronic Case File (ECF) without the appropriate indexing mark;

(25) The copy of 174A-OC-56120 SUB D - 2337 that I have reviewed does not have the required index markings;

(26) This same copy of 174A-OC-56120 SUB D – 2337 that I have reviewed does not have the notation that it was ever uploaded into either ACS or ECF;

(27) Whenever a serial is uploaded into ACS or ECF, it is so noted by the person doing the uploading with a date and the initials of the uploader;

(28) The serialization (2337) of 174A-OC-56120 SUB D documents that it was placed into the paper file (non-computerized) because it would have been impossible to derive the serial number, 2337, without having a paper file with 2336 preceding serials;

(29) I have read the supplemental declaration of Mr. David M Hardy [66-1], filed 9/20/10 in which he describes his efforts to comply with the Freedom of Information Act (FOIA);

(30) It would be impossible for the FBI to locate 174A-OC-56120 SUB D - 2337, without a manual search of the paper file because it was not marked for indexing and therefore could not be located through a computerized search;

(31) A manual search of any FBI paper file would reveal a listing which identifies all serials within that file;

(32) I have personally supervised and participated in manual searches of FBI files to locate documents responsive to civil matters;

(33) The FBI has required the person conducting the manual searches to certify in writing that a thorough search was personally conducted because of indexing failures;

(34) I was commended by FBIHQ for my supervision of the Washington Field Office's (WFO) correction of "significant deficiencies", in the Evidence Control Center (ECC), that were identified in a prior bi/tri-annual inspection by the Inspection Division (ID) of FBIHQ;

(35) The ECC is the repository of all evidence in the FBI;

(36) Every item of evidence is logged into the ECC;

(37) The ECC is restricted access;

(38) The ECC's clerk documents all evidence entry, the identity of anyone who reviews the evidence and anyone who removes the evidence from the ECC, in the ECC log;

(39) Evidence originates with the individual Special Agent's (SA) collection;

(40) The originating SA prepares a FD-192, also known as a "bulky sheet" and or "green sheet";

(41) The originating SA also prepares a FD-302 that identifies the evidence, its origin, from whom it was obtained and relevant case;

(42) The Supervisor or his designee of the violation being investigated reviews the submitted FD-192 and FD-302 for compliance with FBI rules and regulations;

(43) The Supervisor then approves the FD-192 and FD-302, if it is compliant with FBI rules and regulations;

(44) A copy of the FD-192 accompanies the evidence;

(45) Another copy of the FD-192 is filed in the substantive file of the violation being investigated;

(46) The Supervisor of the substantive violation is required by FBI rules and regulations to review the substantive file at least every 120 days to insure compliance;

(47) Any deficiencies are required to be corrected immediately;

(48) Field Office Executive Management is also required to conduct periodic audits of the ECC;

(49) FBIHQ's ID is also required to insure the "integrity" of the ECC during its bi/triannual inspection;

(50) FBIHQ's ID is required to document its findings, in its bi/tri-annual inspection report, in regards to the ECC;

(51) Any removal, relocation and/or disposition of any evidence from the ECC is documented in the file of the substantive violation;

(52) Additionally, any info disseminated from FBI files are documented by a FD-159, which reflects what was disseminated to include the serial number, the date of dissemination, the person/agency to which it was disseminated and the reason for such;

(53) I am aware from my personal experience as a FBI Supervisor that neither ACS nor ECF can be solely relied upon. Communications from FBIHQ to the field offices

have documented various problems with ACS.

I declare under penalty of perjury that the information stated above is true and correct to the best of my knowledge.
