EXPLANATION OF EXEMPTIONS

SUBSECTIONS OF TITLE 5, UNITED STATES CODE, SECTION 552

- (b)(1) (A) specifically authorized under criteria established by an Executive order to be kept secret in the interest of national defense or foreign policy and (B) are in fact properly classified to such Executive order;

The Old Post Office Building, (OPOB), 215 Dean A. McGee Street, Oklahoma City, Oklahoma has a video camera surveillance system with VHS tape backup for floors six through nine of the south stairwell. This is the only video surveillance system with VHS tape backup in the USC and OPOB. The United States Marshals and Court Security Officers had no presence or security responsibilities at the Alfred P. Murrah Federal Office Building.

The surveillance system in the south stairwell of the OPOB is comprised of cameras that are activated by a motion detector on the landing located between the fifth and the sixth floors and by contacts placed at the doors on each of the floors, six through nine. Cameras are placed in each of the hallways of floors six through nine and these cameras are directed towards the south stairwell.

At the conclusion of this interview, DUSM [redacted] provided the interviewing agent with one TDK, HIGH STANDARD, SUPER AVILYN TECHNOLOGY, VHS tape covering the period February 21, 1995 until May 31, 1995 when DUSM [redacted] removed this tape from the surveillance system at 12:45 p.m.

Inspector [redacted] Oklahoma City Police Department (OCPD, telephone number [redacted] came to the Command Post located at 11 Northwest 6th Street, Oklahoma City, Oklahoma, and provided surveillance tapes and photographs of the SOUTHWESTERN BELL parking facility located at 7th Street and Harvey taken on April 19, 1995.

[redacted] also provided copies of these OCPD Standard Supplement Reports regarding the receipt of the SOUTHWESTERN BELL surveillance tapes, the interview of [redacted] and the interview of [redacted] [redacted] provided a computer printout from the Oklahoma City airport police listing flight information of individuals leaving Will Rogers Airport on international flights within the past few days.

[redacted] explained that [redacted] was an employee of the Federal Highway Administration and was in the federal building when it exploded. [redacted] remembered nothing unusual or suspicious happening prior to the explosion. [redacted] was at the SOUTHWESTERN BELL building trying to make a telephone call when he saw the explosion at the federal building. [redacted] noticed a white automobile he believed to be a Jaguar speed down the street away from the building. This Jaguar was driven by a clean shaven white male, approximately 35 to 40 years old with dark wavy hair.

[redacted] STATED THAT HE HAD RECEIVED INFORMATION THAT THE ABOVE [redacted] HAD BEEN PRESENT WHEN THE EXPLOSION HAD OCCURRED AND REQUESTED OUR ASSISTANCE IN ATTEMPTING TO LOCATE AND INTERVIEW HIM.

SGT. [redacted] AND I THEN PROCEEDED TO THE ADDRESS AS GIVEN BY ATF AGENT [redacted] WHERE WE WERE SUCCESSFUL IN LOCATING HIM. THE FOLLOWING IS HIS STATEMENT. b6 b7C

[redacted] STATED THAT HE AND HIS FIANCE [redacted] HAD TRAVELED DOWNTOWN BY BUS TO THE ST. JOE GUILD CHURCH. [redacted] ARE LIVING TOGETHER AND [redacted] IS PREGNANT. [redacted] AND [redacted] BOARDED THE BUS AT NE. 36TH AND KELLY AVE. AT APPROX. 0750HRS. AND ARRIVED IN THE AREA OF THE ST. JOE GUILD CHURCH AT APPROX. 0830HRS. [redacted] THEN WALKED TO THE AREA OF THE CHURCH AND NOTICED THAT THE CHURCH WAS NOT AS YET OPEN. [redacted] RELATED HE AND [redacted] HAD TRAVELED TO THE CHURCH TO OBTAIN FINANCIAL ASSISTANCE FOR A PRESCRIPTION FOR MEDICATION THAT [redacted] HAD RECEIVED FROM HER DOCTOR IN REFERENCE TO HER PREGNANCY.

[redacted] NOTED THAT THE CHURCH WAS STILL CLOSED UPON THEIR ARRIVAL AND THAT A LIGHT THAT WAS USUALLY ON WHEN THE CHURCH WAS OPEN WAS OFF. [redacted] THEN NOTED THAT AN ALARM BOX ON THE GATE TO THE CHURCH HAD BEEN ACTIVATED AND THE LCD READOUT ON THE BOX READ "CHECK 2, #25. [redacted] STATED HE WAS UNAWARE OF THE MEANING OF THE NUMBERS BUT KNEW THE ALARM WAS GOING OFF. [redacted] THEN MET A SECOND BLACK MALE ON THE STREET WHO WAS ALSO AWAITING ASSISTANCE. HE DESCRIBED THE BLACK MALE AS FOLLOWS: B/M 40 WEARING A WHITE BASEBALL CAP WITH THE INSCRIPTION "CELEBRATE 94" IN BLUE AND WHITE LETTERS ON THE FRONT, HAVING A PONY TAIL HELD BACK WITH RUBBER BANDS. [redacted] IN HIS CONVERSATION WITH THIS SUBJECT, LEARNED THE HE WAS SEEKING CHURCH ASSISTANCE IN OBTAINING AN IDENTIFICATION CARD WHICH HE NEEDED TO GO TO WORK AT HIS NEW PLACE OF EMPLOYMENT. [redacted] FURTHER LEARNED THAT THE SUBJECT HAD JUST BEEN HIRED AT THE "MEDALLION HOTEL" IN THE MAINTENANCE DEPARTMENT. [redacted] STATED THAT HE HAD BEEN WATCHING NEWS COVERAGE OF THE INCIDENT AND HE HAD SEEN THIS SUBJECT IN NEWS REEL FOOTAGE.

AS [REDACTED] WAS WAITING FOR THE CHURCH TO OPEN HE RECEIVED A PAGE ON HIS PAGER AND BEGAN LOOKING FOR A PAY TELEPHONE. [REDACTED] STATED THAT HE WAS LOOKING DIRECTLY AT THE MURRAH BUILDING WHEN SUDDENLY HE SAW A FIREBALL ERUPT FROM THE UPPER FLOORS OF THE BUILDING. [REDACTED] AND [REDACTED] WERE BOTH KNOCKED DOWN BY THE BLAST WHICH HE BELIEVED TO HAVE COME FROM SOMEWHERE IN THE UPPER PART OF THE BUILDING SPECIFICALLY STATING THE 6TH FLOOR OR ABOVE.

[REDACTED] THEN STARTED ACROSS THE STREET TOWARDS THE BUILDING AND WAS CROSSING THE STREET TO THE MURRAH BUILDING WHEN SUDDENLY A VEHICLE SPED DOWN THE STREET ALMOST STRIKING HIM. [REDACTED] OBSERVED THE VEHICLE TO BE TRAVELING SOUTH AT A HIGH RATE OF SPEED AND PASSED BY HIM THEN TRAVELED ONE BLOCK SOUTH AND THEN TURNED EAST IN THE NEXT BLOCK. [REDACTED] BELIEVED THIS TO BE STRANGE AS THE VEHICLE WAS TRAVELING TOWARDS AND THEN BY THE AREA OF THE EXPLOSION INSTEAD OF AWAY. [REDACTED] STATED HE OBTAINED A GOOD LOOK AT THE DRIVER AS THE VEHICLE SPED BY AND DESCRIBED HIM AS FOLLOWS: W/M 35-45 CLEAN SHAVEN, NEAT IN APPEARANCE, WEARING A WHITE SHIRT, HAVING DARK COLORED WAVY HAIR COMBED STRAIGHT BACK. [REDACTED] DESCRIBED THE VEHICLE AS A WHITE IN COLOR MEDIUM SIZED VEHICLE OF FOREIGN MAKE. [REDACTED] FURTHER BELIEVED THE VEHICLE TO POSSIBLY BE A JAGUAR AND RELATED HE LIKES CARS AND WAS ALMOST SURE THAT IT WAS A JAGUAR. b6

IN REFERENCE TO THE SUBJECT DRIVING THE VEHICLE, [REDACTED] STATED HE IS FROM CHICAGO ORIGINALLY AND THAT IN HIS NEIGHBORHOOD PEOPLE FROM THE MIDEAST RAN SEVERAL GROCERY STORES IN THE AREA AND THAT HE IS FAMILIAR WITH THEIR APPEARANCE. HE STATED THAT HE BELIEVED THE DRIVER TO BE OF EASTERN DESCENT.

[REDACTED] DID ADMIT TO HAVING WATCHED TELEVISION COVERAGE OF THE INCIDENT PRIOR TO THE INTERVIEW AND IT IS THE INVESTIGATORS OPINION THAT HE WAS VERY SURE OF THE MAKE OF THE VEHICLE BUT SOMEWHAT LESS CONFIDENT OF THE RACE OF THE DRIVER. b6

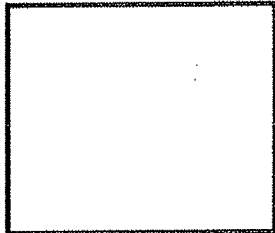
BODY OF REPORT:

On 4-18-95, I was assigned to go to the O.C.P.D. Command Post
located at 6th N. Harvey. Upon my arrival at that location at approximately
1020 hours, I was assigned by Lt. [redacted] to stand by along with Det.
[redacted] Lt. [redacted] informed [redacted] and myself that we were to
conduct brief interviews with any walk-up survivors.

At approximately 1030 hours, I was informed that the above person,
[redacted] had been in the Federal Building during the explosion and had
made his way to the Command Post. I conducted a brief interview with him. It
should be noted that [redacted] was suffering from numerous cuts on his face
and arms and was somewhat disoriented.

[redacted] said that he is an employee of the Federal Highway
Administration and that his office [redacted] was located on the 4th floor of the

While in the parking lot on the south west corner of 7th and N. Harvey I observed two security cameras mounted on poles. The cameras were mounted so that they could sweep the parking area.

I brought the cameras to the attention of Captain [redacted] Commander of the Homicide Unit. He gave me the assignment of locating the owner of the parking lot and of obtaining the tapes if there were any.

Sgt. [redacted] Sgt. [redacted] and I went to the offices of Southwestern Bell Telephone, located at 800 N. Harvey. We were directed to the office of the President of the company. [redacted] I explained our interest in any tapes that may exist. [redacted] assigned [redacted] General Attorney, the task of locating the tapes. [redacted] brought three tapes to me. He printed the day WED on each tape. The tapes were then numbered #1, #2 and #3.

eventually aired on TV was still three shades too dark. [REDACTED] further stated that the man he observed was not dark complected at all. In addition to the error in the complexion on the composite [REDACTED] advised that the hair was not an accurate portrayal of the individual at the Dreamland Motel. [REDACTED] advised that the composite's hair was also much too dark. The person he observed had much lighter hair, describing it as light or sandy. On April 16, 1995, there were two video surveillance cameras at the 121 Dean A. McGee location. One was in the alley behind the building and was pointed north. The camera was located between the 405 Broadway location and 111 Dean A. McGee. The alley is a north/south alley and this camera could be rotated to look down 3rd Street, but was not turned that direction at that time. The second camera behind 121 Dean A. McGee was located at the northeast corner of the building, pointed east down the alley. This was a fixed camera and did not move.

There were six cameras located at 707 North Robinson. The first camera was in the alley on the north side of the building pointed east. This camera showed the docking area on the north side of the building. The second camera was in the center of the parking lot, more or less in the north center part of the lot. This camera was aimed south toward the loading dock. The third camera was set in the center of the lot and made a half circle picture to the east and north toward Robinson Street and toward 7th Street. The fourth camera was located in the visitor's parking lot at 7th and Harvey and was mounted on the alley side on the southeast corner of the lot. This camera faced north up Harvey. The fifth camera was located between 7th and 8th on Harvey in the parking lot facing south. This camera would show a view from 7th to 6th and down Harvey. The sixth camera was located between Hudson and Harvey on 7th Street on the alley side. This was the southwest corner of the lot and the camera faced north. This camera would show the parking lot and a little of 7th Street.

These cameras were serviced and installed by SENSORMATIC.

There were no surveillance tapes remaining from October, 1994, according to [REDACTED]. He stated that the tapes from the date of the bombing were turned over to the Federal Bureau of Investigation (FBI) by either [REDACTED]. [REDACTED] He did not know if there were any tapes from April 16, 1995. If these were not on the tapes already turned over to the FBI, they have been taped over.
