

EXPOSED: FBI Transforms Average Citizens into Domestic Terrorists

Susanne Posel (OC) : Human Rights Watch (HRW) issued a report concerning a number of high-profile domestic terrorism plots that had direct involvement with government agents; showing how the US government has a hand in creating circumstances that produce domestic terrorism.

Following the 9/11 attack on the World Trade Center (WTC), “informants” were involved or led “sting operations” that could easily be construed as entrapment.

The HRW wrote: “The US Justice Department (DoJ) and the Federal Bureau of Investigation (FBI) have targeted American Muslims in abusive counterterrorism ‘sting operations’ based on religious and ethnic identity.”

The 214 page report synthesized “27 federal terrorism cases from initiation of the investigations to sentencing and post-conviction conditions of confinement.”

Andrea Prasow, deputy director of the HRW and co-author of the report, commented: “Americans have been told that their government is keeping them safe by preventing and prosecuting terrorism inside the US. But take a closer look and you realize that many of these people would never have committed a crime if not for law enforcement encouraging, pressuring, and sometimes paying them to commit terrorist acts.”

Prasow’s point has been made in the news reports of FBI terrorists who were arrested by the agency prior to allegedly carrying out their destructive and potentially deadly scheme.

The report states: “In some cases the FBI may have created terrorists out of law-abiding individuals by suggesting the idea of taking terrorist action or encouraging the target to act.”

Shockingly, 18% of the 494 cases viewed that were “related to terrorism [were] not for thwarted plots but for “material support” charges, a broad category expanded further by the 2001 Patriot Act that permits prosecutors to pursue charges with tenuous connections to a terrorist act or group.”

Along with legitimate terrorists, there are a plethora of “targeted people who do not appear to have been involved in terrorist plotting or financing at the time the government began to investigate them. And many of the cases involve due process violations and abusive conditions of confinement that have resulted in excessively long prison sentences.”

With 50% of convictions stemming from “informant-based” intelligence, it appears that anonymous accusers are the foundation by which the FBI conducts “sting operations” on “law-abiding individuals”.

In 2010, the FBI set up a young and impressionable man in Oregon named Mohamed Osman Mohamud with the materials need to create an IED, then encouraged him to attend a tree lighting ceremony at the Portland Pioneer Courthouse Square where thousands of innocent people could be hurt.

The FBI admitted that they had recruited Mohamed by email because they suspected he was involved in terroristic activities in the past. This made him a good candidate to become another US government patsy.

The FBI also alluded that they may be able to use Mohamed in another fake terror plot if he were willing to travel to Pakistan and participate in a jihad.

Three years ago, Loretta Lynch, former US Attorney from the Eastern District of New York and current replacement for Eric Holder as US Attorney General, was the prosecutor in the case against Quazi Mohammad Rezwanul Ahsan Nafis, who was recruited by the FBI in a manufactured bomb plot.

The FBI stated Nafis came to the FBI agent assigned to him and told that agent he wanted to blow up the New York Federal Reserve Bank.

Lynch explained: “This case means that there’s still a concerted effort by al Qaeda to insert individuals into the U.S. who will carry out their plan to disrupt the economy and to do great destruction and damage. Individuals who essentially are not necessarily tied to a larger group but come here looking to recruit other people who share the same views, and look for targets and carry out acts of destruction.”

The FBI claimed Nafis was approached by the agent assigned to him at the Southeast Missouri State University (SMSU) where Nafis allegedly was obtaining a degree in cybersecurity on a student visa .

However, records show that Nafis is not a student at SMSU.

The FBI agent assigned to Nafis gave him 1,000-pounds of ammonium nitrate and other materials to build an improvised explosive device (IED).

Under watch of the FBI, Nafis assembled the IED at an undisclosed warehouse in New York. The FBI said Nafis attempted to detonate the “fake” bomb at a hotel, where he was taken into custody. The “infiltrating” FBI agent brought Nafis to the warehouse in a van reported The Wall Street Journal.

Nafis allegedly told the agent that his first plan was to blow up the NY Fed. If he was unable to do so, he had a “Plan B”. After coercing from the FBI agent, Nafis

also produced a written statement of his intentions where he said that Osama bin Laden was the justification for his impending actions.

The FBI agent made sure to create a video where Nafis admitted to his plans. This recorded statement was to be shown to the American public after the attack. Nafis was recorded on tape saying he wanted to “destroy America.” The FBI was careful to set up the necessary evidence to not only incriminate Nafis as a patsy, but also use the evidence to create a link between al-Qaeda and the nation of India.

As reports came out about Nafis it was uncovered that an accomplice was implicated and arrested in San Diego for the NY Fed bomb plot.

Howard Willie Carter II happened to have been arrested on unrelated child pornography charges, when it was uncovered that Carter had email correspondence with Yaqueen (an apparent nickname of Nafis).

In the same year, the underwear bomber, who was set up by the FBI, became a justification of the Obama administration for warrantless surveillance on Americans.

However, it soon became apparent that the bomber was actually a CIA employee and that the federal agency manufactured the event so they could “foil” nefarious plans.

Even Robert Mueller, director of the FBI claimed that the CIA did not manufacture the plot, but rather that Congress should view their operation as proof that more intrusions into US citizen’s privacy was necessary and that “the amendments that are up for passage again — reenactment — at the end of this year [are] absolutely essential in our efforts to address this threat.”

In 2013, Andrea Bowden was arrested by the Federal Bureau of Investigations (FBI) for allegedly threatening to commit a mass shooting at Gateway Community College in New Haven, Connecticut.

Bowden’s handler claims that she made several text messages and have verbal conversations with them discussing her bomb plot and intent to commit mass murder.

The FBI agent went on to say: “The FBI’s investigations into threats of violence will be swift and thorough. In this day and age, the making of any threat will not and cannot be tolerated. There will be consequences. The Agents and Task Force Officers assigned to the New Haven Division’s Joint Terrorism Task Force and the U.S. Attorney’s Office did an outstanding job in addressing this threat from the time it was first reported to the FBI until the successful arrest of the subject.”

Bowden was accused of owning guns and manufacturing 2 IEDs. However, when the FBI searched Bowden's home no guns or IEDs were found. The New Haven police department said that Bowden was wanted on outstanding warrants for harassment and endangerment.

Bowden is one of a long list of patsies created by the FBI to justify the threat of domestic terrorism in the US.

In the same year, Matthew Aaron Llaneza was accused by the FBI in a manufactured terror plot involving an IED.

This entrapment scheme pinned Llaneza, who had a history of mental illness, on building an IED that would detonate at a San Jose branch of Bank of America (BoA).

Officials claimed Llaneza wanted to start a civil war by aligning anti-government militias to the storyline.

In this case, the FBI press release stated that "unbeknownst to Llaneza, the explosive device that he allegedly attempted to use had been rendered inoperable by law enforcement and posed no threat to the public."

Llaneza was charged with "attempted use of a weapon of mass destruction against property used in an activity that affects interstate or foreign commerce."

The FBI asserted that it was "Llaneza's stated goal was to trigger a governmental crackdown, which he expected would trigger a right-wing counter-response against the government followed by, he hoped, civil war. Llaneza's arrest was the culmination of an undercover operation during which he was closely monitored by the FBI's South Bay Joint Terrorism Task Force."
