I FIND YOUR LETTER TROUBLING. YOU SAY THAT YOU DON'T WANT ANYTHING FROM ME. THEN YOU SAY THAT WHAT YOU WANT FROM ME IS TO MAKE A DRAWING OF WHAT THEY FOUND IN THAT HOLE AND TO GIVE IT TO STAN. I ASSUME "THEY" MEAN THE FBI & ATF, AND "THE HOLE" REFERS TO MY FORMER HOME IN KANSAS.

AND IF I DON'T DO SUCH THAT YOU ARE GOING TO "TRY AND BLOW THIS WHOLE THING."

I DON'T KNOW IF THIS IS A THREAT, BLACKMAIL, OR WHAT? BUT I DON'T LIKE THE TONE OF IT.

YOU ALSO SAY -

SID JUST INTERRUPTED ME & TRIED TO TELL ME THAT HE KNOWS ALL THAT'S GOING ON & BASICALLY REPEATED WHAT HE SAID IN HIS LETTER.

I SAID - BUT YOU ARE WANTING SOMETHING FROM ME. HE SAID IT WAS FOR STAN. I SAID - WHY? HE SAID - BECAUSE HE'S MY DOG. (I DON'T KNOW WHAT DOG MEANS.) SID SAID THAT TITO HAS BEEN GOING TO SEE THE FBI & THAT TITO IS SETTING ME UP. SID SAID THAT IF STAN DOESN'T HITCH A RIDE WITH OUR DEAL THAT HE WILL BLOW THE WHOLE THING. I SAID - YOU CAN TELL ANYONE YOU WANT ANYTHING, AND I WILL ANSWER ANY QUESTION THEY WANT TO ASK WITH A POLYGRAPH REGARDING THE ISSUE YOU'RE TALKING ABOUT. SID SAID A FEW MORE THINGS. THEN I SAID - I'M TRUSTING GOD WITH THIS AND..... SID CUT ME OFF AND AS HE WAS WALKING AWAY HE REMARKED - YOU'RE LIKE THAT CURBAN WITH GOD. (THE CURBAN IS TITO) (SID & STAN ARE A.B.'S & RACISTS.)

SID LATER CAME BACK & APOLOGIZED, BUT STILL WANTS THAT DRAWING FOR STAN. I TOLD SID - I'M THE HOT POTATO HERE. BUT YET I DON'T WANT TO CREATE ANY PROBLEMS. HE WAS TOLD TO GO TO HIS <sup>BY C</sup> CUCK

P.S. - I DO HAVE STAN'S LETTER.

Dear Mr. Ashcroft,

Good day. I am TERRY L. NICHOLS - the one who has now been tried twice for the Oklahoma City bombing - once each by the Federal Gov't and the State of Oklahoma, who each sought the death penalty against me.

I am writing to you at this time in regards to an unresolved issue which concerns both my Federal & State trials and thus the F.B.I.'s investigation & the D.O.J.'s actions.

This matter involves 2 individuals who each testified in both the Federal & State trials as prosecution witnesses and who each deliberately, intentionally and willfully lied numerous times and did so with the full knowledge & support of both the Federal Gov't. & the State Gov't. prosecutors along with others. Those

2 people are ROGER MOORE & KAREN ANDERSON formerly of Royal, AR., now residing in the State of Florida.

They lied about different things, but I will focus only on one issue and primarily on Roger Moore. If you do not know of Mr. Moore's lies and his background then I strongly recommend that you check with your people regarding Mr. Moore's shady activities as well as his knowledge, purchase, possession, and distribution of KINE-STIK" (a.k.a., KINE-PAK) along with other explosive components. Your people know very well what I'm referring to.

Now I felt it was only right to come to you first regarding this issue to give you the opportunity to set the record straight, for I hear that you're a man of high integrity. However, if you're not willing to publicly acknowledge & announce what involvement Roger Moore had in the Oklahoma City bombing then you leave me no choice, because I will then do so.

I'm also able & willing to provide physical evidence proving that Mr. Moore not only lied repeatedly in both Federal & State courts but that he possessed explosive components such as Kine-Stik.

In addition, Mr. Moore sold blasting caps among other things. Thus he was and is very knowledgeable about various types of explosives.

The truth is there is no way that the F.B.I. and/or

other Federal agencies did not know of Mr. Moore's knowledge of explosives & willful coverup of such facts by the Federal Gov't.

Now the Oklahoma City bombing occurred on President Clinton & Atty. Gen. Janet Reno's watch as did the initial coverup with Mr. Moore. However, this coverup is continuing under your watch & President Bush's - This is not good and it could easily work against you and the current administration with devastating ~~rest~~ results. I say this only as a fact.

By the way, I'm not looking for any favors or such. I am simply wanting the full truth to come out. Thus I am willing to disclose publicly all I know, including how I was involved in the OKC bombing. This could be done in a cooperative effort which would maintain this current administration's integrity - the choice is yours.

You and many others may think otherwise, but I never intended nor planned for the OKC bombing to occur.

I am prepared to go public about the above facts after September 30, 2004. If you want this to work in a positive way then I strongly suggest that you contact me as soon as possible. Time is short, don't wait till the last minute.

If you are going to deny or try to manipulate the facts that Roger Moore had absolutely no part, directly or indirectly, in the Oklahoma City bombing and that.

he has no knowledge of explosives (particularly Kine-stik), nor possessed any, or is not in any way connected with the Federal Gov't. in some capacity, then please do not waste your time or mine in contacting me.

Should you choose to deny, manipulate or remain silent it will be clear evidence to me and others that you want to ignore, deny and coverup the truth and suppress it from the public, not to mention the survivors & victims. However, I would hope that you would do the right thing for all those concerned.

I look forward in hearing from you soon.

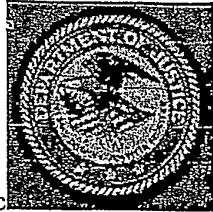

TERRY NICHOLS' NOTES

RE: GETTING FINGERPRINT, DNA & OTHER TESTS DONE ON THAT CASE OF LITTLE TUBES OF NITROMETHANE & OTHER VITAL PIECES OF EVIDENCE TO SHOW ROGER MOORE'S INVOLVEMENT IN THE ORC BOMBING, HIS LIES IN COURT, AND SUPPLYING TIM MEVEIGH WITH EXPLOSIVE COMPONENTS, AND GOVT COVERUP OF SUCH.

NOTE: THAT CASE OF NITROMETHANE IS ONE OF THE 2 PART COMPONENT KNOWN AS KNE-STIK (A.K.A. - KNE-PAK). ALSO REFERRED TO AS A BINARY EXPLOSIVE COMPONENT.

THE <sup>WITH GREG</sup> SOLE PURPOSE OF DISCUSSING MY KNOWLEDGE & POSSESSION OF THAT CASE OF NITROMETHANE WHICH CAME DIRECTLY FROM ROGER MOORE'S ROYAL, ARKANSAS HOME IS TO REVEAL THE TRUTH OF MOORE'S INVOLVEMENT IN THE ORC BOMBING, HIS SUPPLYING MEVEIGH (M.V.) WITH KNE-STIK, AND THE COVER UP & PROTECTION OF MOORE'S INVOLVEMENT OF SUCH BY THE FED. GOVT.

GREG'S FULL NAME IS - GREGORY SCARPA<sup>JR.</sup> REG # 10099-050. GREG IS HOUSED IN THE CELL (#8) NEXT TO ME, I'M IN #9. THE WAY OUR CELL DOORS ARE NEXT TO EACH OTHER IT IS VERY EASY TO PASS NOTES/LETTERS TO EACH OTHER. BRAVO (TITO) IS IN CELL #7 NEXT TO GREG (PASSING NOTES TO TITO IS HARD EVEN FOR GREG)

AFTER ABOUT A WEEK OF WRITTEN CORRESPONDANCES BETWEEN GREG & MYSELF I DECIDED THAT IT WOULD BE BETTER IF I KEPT ALL OF GREG'S LETTERS RATHER THAN TO SEND THEM BACK TO HIM. PLUS TITO HAD SUGGESTED THAT I DO THE SAME SO THAT I WOULD HAVE SOME TYPE OF DOCUMENTATION AS TO WHAT TRANSPIRES BETWEEN GREG & MYSELF. THIS TODAY (FEB. 24 '05) I'M KEEPING GREG'S LETTERS (ALL OF THEM) AND AT TIMES I INTEND TO MAKE MY OWN NOTES REGARDING HIS LETTERS.

TO SET THINGS IN THE RIGHT PERSPECTIVE, ORIGINALLY IT WAS TITO WHO WAS ASKING ME QUESTIONS ABOUT THE DAILY OKLAHOMAN NEWSPAPER ARTICLE DATED NOV. 28, 2004 REGARDING THE NICHOLS' CONFESSION TO THE OKC BOMBING BY WAY OF FAILED PLEA-BARGAIN NEGOTIATIONS. TITO ASKED ME ABOUT THE QUESTION WHICH WAS NOT FULLY ANSWERED REGARDING THE WHEREABOUTS OF ANY UNUSED BLASTING CAPS WHICH WAS STOLEN FROM THE MARION QUARRY.

I TOLD TITO THAT I DIDN'T DISCLOSE THE LOCATION OF THOSE BLASTING CAPS BECAUSE (B/C) IT WOULD ALSO DISCLOSE WHERE THAT CASE OF NITROMETHANE WAS AND I DIDN'T BELIEVE THAT THE STATE PROSECUTORS (OKLAHOMA) WOULD DO THE PROPER INVESTIGATION WHICH WOULD EXPOSE THE TRUTH OF MOORE'S INVOLVEMENT IN THE OKC BOMBING NOR THE FED GOV'T COVER UP OF SUCH & PROTECTION OF MOORE. THIS CONVERSATION WAS HELD DURING ONE OF OUR OUTSIDE REC PERIODS IN EARLY FEB. 2005.

LATER TITO DISCUSSED OUR CONVERSATION WITH (W/) GREG AND DURING ANOTHER OUTSIDE REC PERIOD BOTH TITO & GREG SAID THAT IF I WOULD GIVE GREG THE INFORMATION OF WHERE THOSE ITEMS COULD BE FOUND GREG'S INDEPENDENT INVESTIGATOR WHO IS WORKING FOR A CONGRESSIONAL COMMITTEE REGARDING GOV'T MISCONDUCT COULD REALLY USE THAT INFO & EVIDENCE TO CREATE PROVE SUCH GOV'T MISCONDUCT & COVER UP, AND THUS EXPOSE THE TRUTH OF MOORE, THE BOMBING & MUCH MORE.

THE REASON THAT I'M HAVING DISCUSSIONS W/ GREG & TITO IS B/C I CANNOT TRUST ANY GOV'T AGENCY TO DO WHAT I WANT DONE WHICH IS RECOVERING THESE ITEMS, EXAMINING & TESTING THEM, DO A PROPER UNBIASED INVESTIGATION, AND EXPOSE THE TRUTH TO THE PUBLIC, PARTICULARLY TO THE OKC VICTIMS & SURVIVORS.

I FEAR THAT IF ANY GOV'T AGENCY DOES THE RECOVERY THAT THEY WILL INTENTIONALLY DESTROY THESE ITEMS ON SITE BY CLAIMING THEM TO BE UNSTABLE & TOO DANGEROUS TO HANDLE - JUST LIKE WHAT OCCURRED IN THE MIDWEST BANK ROBBERY CASE AND THERE WAS EVEN A JUDGE'S ORDER TO PRESERVE ALL EVIDENCE, BUT LAW ENFORCEMENT TOTALLY IGNORED THE ORDER AND DESTROYED CERTAIN BULLETS WHICH WERE SIMILAR TO THOSE STOLEN FROM THE MARION QUARRY.

Nichols is serving multiple life terms for his role in the 1995 bombing of the Alfred P. Murrah Federal Building, Oklahoma City, Oklahoma.

Nichols does not trust agents from the Federal Bureau of Investigation (FBI). The FBI should have investigated [redacted] and [redacted] dealings with explosives in 1994 and 1995. The FBI may be protecting [redacted] because [redacted] was a confidential source for the FBI. Several years ago, Nichols wrote [redacted] a letter discussing the return of property recovered by the FBI during the investigation of the 1995 Oklahoma City bombing. [redacted] obtained property that belonged to Nichols but was given to [redacted]. On the second page of the letter, Nichols' inquired if [redacted] would like "everything" back. "Everything" included a case of nitromethane tubes that Nichols had stolen from [redacted] in 1994. The box of nitromethane tubes was opened but undisturbed when Nichols robbed it from [redacted] residence. [redacted] did not list nitromethane tubes as property stolen during the 1994 robbery. Nichols wanted [redacted] to know that Nichols had the nitromethane tubes from the 1994 robbery.

The case of nitromethane tubes Nichols' robbed from [redacted] residence were not used in the 1995 Oklahoma City bombing. On the day the Oklahoma City truck bomb was built, McVeigh already had enough Kinestick for the bomb.

Kinestick is a binary explosive consisting of a tube of nitromethane and a tube of ground ammonium nitrate. Nichols attended a gun show where a man was selling one quart of ground ammonium nitrate for \$32.00 and other chemicals for making bombs.

The man became angry because Nichols identified the ground substance as fertilizer which could be bought for \$5.50 for a fifty pound bag. Nichols obtained a few bags of ammonium nitrate, ground the pellets into a powder, and began selling small quantities at gun shows. Prior to Nichols' trial, Nichols did not know that one component of Kinestick was ground ammonium nitrate. Nichols had knowledge of ammonium nitrate in a pellet form that is used farming.

Nichols could not recall if the Kinestick used by McVeigh to build the truck bomb was stored in the rented storage unit located in Herington, Kansas. Nichols is aware that McVeigh had access to the rented storage unit from November 1994 through April 1995. Nichols recalled that [redacted] associate of McVeigh, testified that [redacted] and McVeigh went into the rented storage unit in December 1994.

McVeigh and Nichols became friends because of shared common interests. The shared common interests include a "survivalist mentality," an interest in guns and both men were financially conservative. McVeigh and Nichols were both stationed at Fort Riley, Kansas. McVeigh did not waste money on alcohol or women. Nichols observed McVeigh when McVeigh began lending money to other soldiers at high interest rates.

Nichols does not feel safe revealing the name of an unidentified individual that may have knowledge of the 1995 Oklahoma City bombing. The unidentified individual could cause harm to Nichols [redacted]

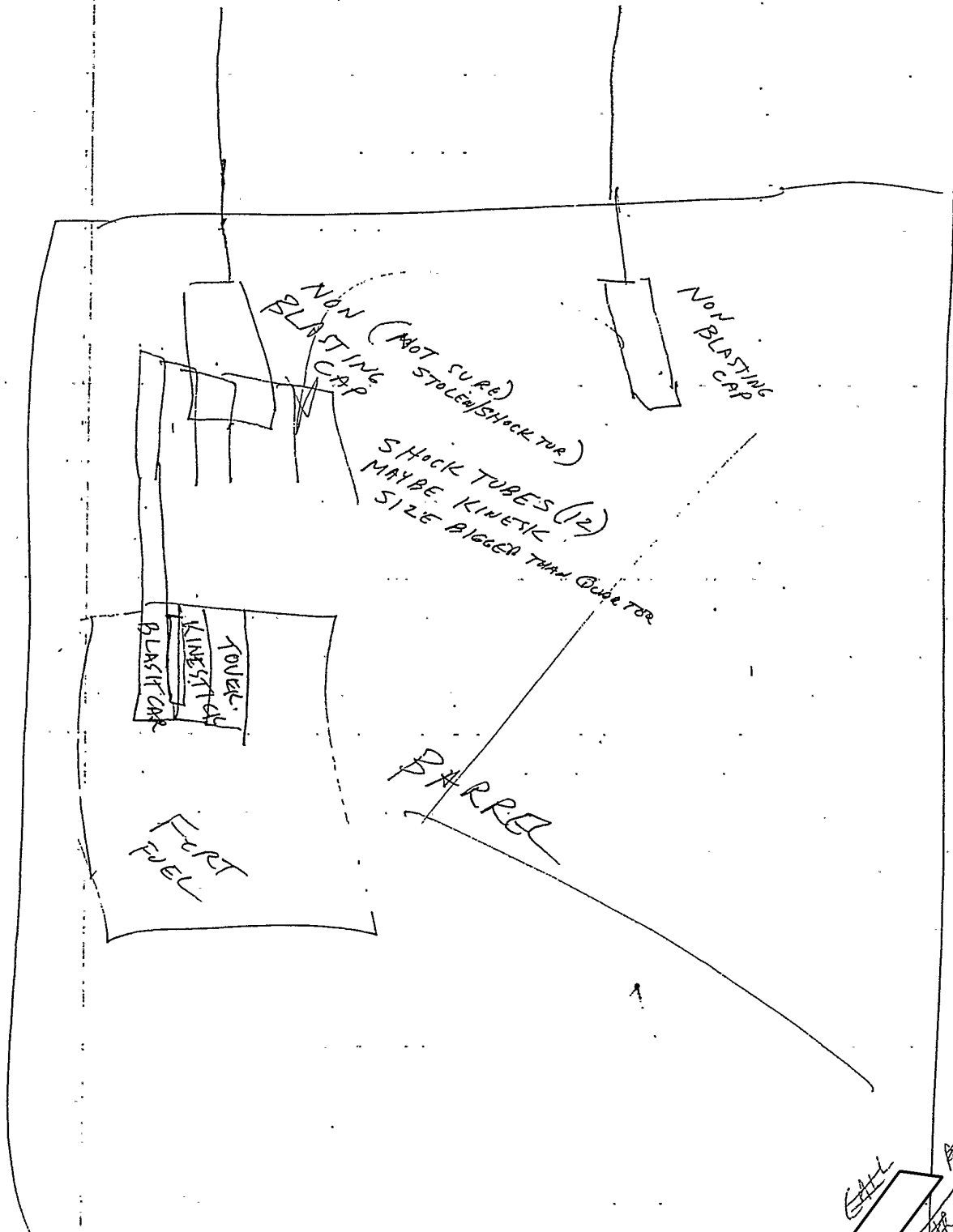

Nichols provided a wiring diagram of the truck bomb used in the 1995 bombing in Oklahoma City. Nichols watched McVeigh connect the detonation system running from the cab of the rental truck to the barrels of fertilizer. Nichols and McVeigh stayed in the back of the rented Ryder truck while they constructed the truck bomb. McVeigh positioned the barrels near the front of the truck and Nichols stayed near the back door because there was more room. 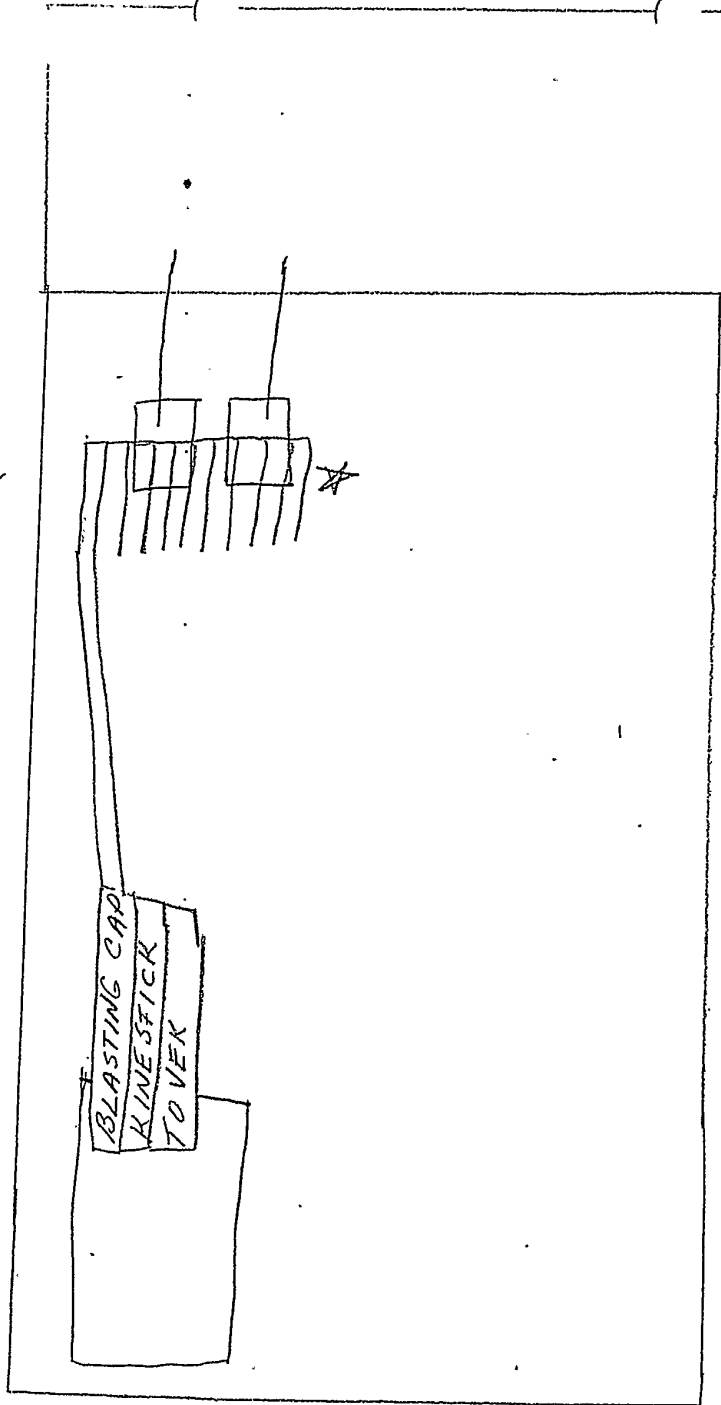
