

## EXPLANATION OF EXEMPTIONS

- (b)(8) contained in or related to examination, operating, or condition reports prepared by, on behalf of, or for the use of an agency responsible for the regulation or supervision of financial institutions; or
- (b)(9) geological and geophysical information and data, including maps, concerning wells.

- (k)(6) testing or examination material used to determine individual qualifications for appointment or promotion in Federal Government service the release of which would compromise the testing or examination process;
- (k)(7) material used to determine potential for promotion in the armed services, the disclosure of which would reveal the identity of the person who furnished the material pursuant to a promise that his/her identity would be held in confidence.

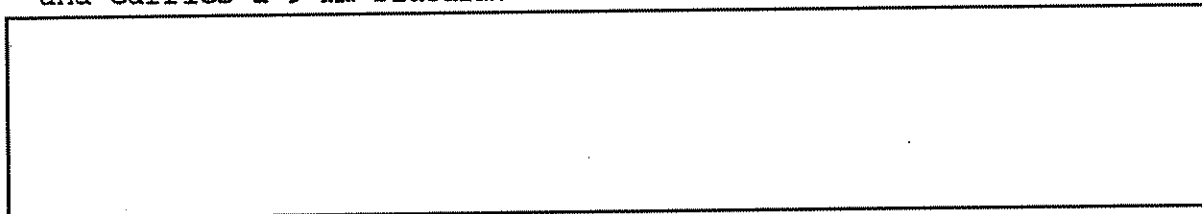

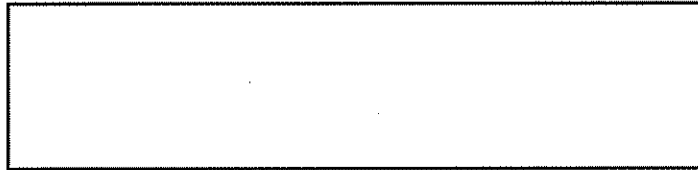

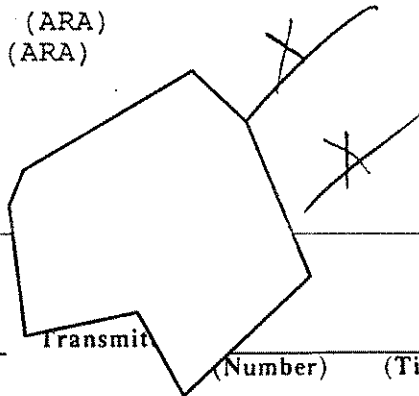

Concerning investigation within Philadelphia Division, referenced communication set forth source information to the effect a Skinhead meeting reportedly occurred at or near Macungie, Pennsylvania (PA), during 10/92, and there were approximately 75 Skinheads in attendance, half of whom were from PA. An individual by the name of [redacted] [redacted] formerly a member of the Aryan Nations, was in attendance. Boston Division requested an effort be made to confirm such meeting occurred and to identify [redacted]

On 3/2/93, [redacted] provided the following information:

[redacted] is a [redacted] born [redacted] pounds, [redacted] hair, SSAN [redacted] and usually has a full beard. [redacted] is well known to the PSP and Troopers working in the vicinity of [redacted] residence have been cautioned that he should be considered armed and dangerous. Trooper [redacted] stated [redacted] holds himself out to be [redacted] is apparently affiliated with the KKK, as well as a tax protest organization. [redacted] resides in a rural area and frequently has [redacted] relating to his claimed [redacted] In the past, [redacted] has openly and publicly demonstrated his membership in the Ku Klux Klan and has drawn substantial media attention.

[redacted] reportedly has numerous weapons and neighbors have complained frequently in the past concerning weapons being fired on the [redacted] property and there have been reports of apparent automatic weapons firing. There have been unconfirmed reports in the past, that [redacted] is involved in the trafficking of controlled substances. [redacted] reportedly was/is a [redacted] is originally from [redacted] and graduated from the [redacted]

During the early 1970s, [redacted] resided in [redacted] During this period, [redacted] reportedly was acquainted with [redacted] born [redacted] described as a "mass murderer" who reportedly admitted to 38 individual murders, most in the Daytona Beach, Florida (FL) area and several of which were in New Jersey. Investigators of the NEW JERSEY STATE POLICE (NJSP) reportedly were skeptical concerning [redacted] admissions relative to at least two of the NJ murders [redacted]

[redacted] Investigation by the NJSP focused on [redacted] who reportedly moved from NJ to PA to escape the investigative

scrutiny of the NJSP. No charges were lodged against [redacted] relative to the NJSP murder investigations.

[redacted] is not known to have any present employment and has worked as a [redacted] in the past. [redacted] lives with his wife [redacted] as well as another female who reportedly had a child [redacted]

Trooper [redacted] reiterated that [redacted] has periodic meetings at his rural farm property and such reportedly have a religious connotation. [redacted] reportedly has a persuasive personality and does successfully attract many young people to his reported "ministry." Trooper [redacted] confirmed that during October, 1992, there was a large meeting on the [redacted] property related to his "ministry" and Skinheads were in attendance.

Trooper [redacted] stated a vehicle on the [redacted] property bears an Iowa license tag and same is registered to the CHURCH OF JESUS CHRIST, 510 South 9th Street, Marshall, Iowa.

Trooper [redacted] stated he has received unconfirmed reports that [redacted] is considering traveling "west" in the immediate future to attend a trial for an individual(s) who reportedly was involved in the murder of a Deputy U.S. Marshal. Trooper [redacted] stated this unconfirmed information did not include any assertion or suggestion that [redacted] was contemplating any acts of violence in the event he would undertake such reported travel.

Trooper [redacted] stated he has had personal contact on several occasions with [redacted]. On each occasion, [redacted] has been civil, however, he consistently makes "baiting remarks" and appears to enjoy the prospect of possible or future confrontation. [redacted] has denied the presence of automatic weapons on his property or that same were ever fired on his property, however, he has made remarks to the effect that the PSP will never have the opportunity to search his property to determine if automatic weapons are present. In short, according to Trooper [redacted] while [redacted] has been civil to date, he is a "frightening personality" and the PSP is very concerned that there will be a future violent confrontation with [redacted]

Per request of PSP, debrief [redacted] concerning visit to [redacted] PA, with particular emphasis on the following:

Weapons or explosives present on the [redacted] property; possession or access to automatic weapons by [redacted]; involvement by [redacted] in the trafficking of controlled substances; etiological beliefs and objectives which could lead to future violent confrontation with law enforcement personnel; a general assessment concerning the likelihood of future violent undertaking by [redacted] or his encouragement of same by "followers of his ministry."

On November 1, 1993, [redacted] advised Detective [redacted] and SA [redacted] of the following:

Source advised that [redacted] the White Aryan Resistance (WAR), recently addressed a Black Panther convention at an unknown location. [redacted] maintains a good relationship with both the Black Panthers and Louis Farrakhan (Nation of Islam). This relationship is based upon their separatist beliefs that members of their respective organizations should have their own states.

As a result of this relationship, members of the Black Panther have recently contacted [redacted] who in turn, referred them to [redacted] of the United States of America Nationalist Party (USANP). [redacted] is the [redacted] of the USANP.

Source states that [redacted] subsequently contacted a female Black Panther who the source identified as [redacted] at telephone number [redacted] [redacted] is allegedly the [redacted] of the Black Panthers located at 3131 N.26th Street, Milwaukee, Wisconsin. Source provided the telephone number for the above Black Panther clubhouse as (414) 444-1368.

Source further stated that [redacted] had been attempting to contact [redacted] (phonetic) who allegedly is [redacted] of the Black Panthers in Milwaukee, Wisconsin. However, [redacted] [redacted] apparently acts as a intermediary between [redacted] and outsiders.

The purpose of contacting the Black Panthers is to arrange a meeting between them and the USANP to discuss their common goals and ways to achieve them.

The Black Panthers, Nation Of Islam and White Aryan Resistance are aligned in the state of California as a result of [redacted] efforts. [redacted] goal is to align them with the USANP in the Philadelphia area.

Although [redacted] doesn't belong to a group, per se, he controls the White Aryan Resistance (WAR). WAR is aligned with the Aryan Nations and the Posse Comitatus including the Christian Posse Comitatus (CPC) which is [redacted] [redacted] and is aligned with the USANP in Philadelphia which is [redacted] [redacted] However, neither [redacted] or [redacted] apparently like [redacted]

Regarding [redacted] the source states that he believes [redacted] may be involved in some sort of counterfeiting



operation. Source believes this because [redacted] Has two(2) printing presses at his compound [redacted]

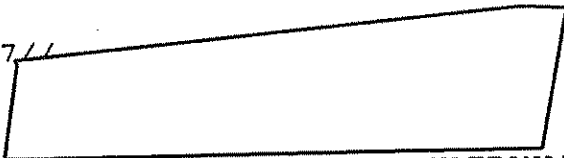
