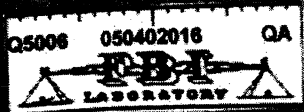
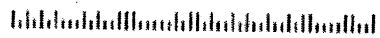

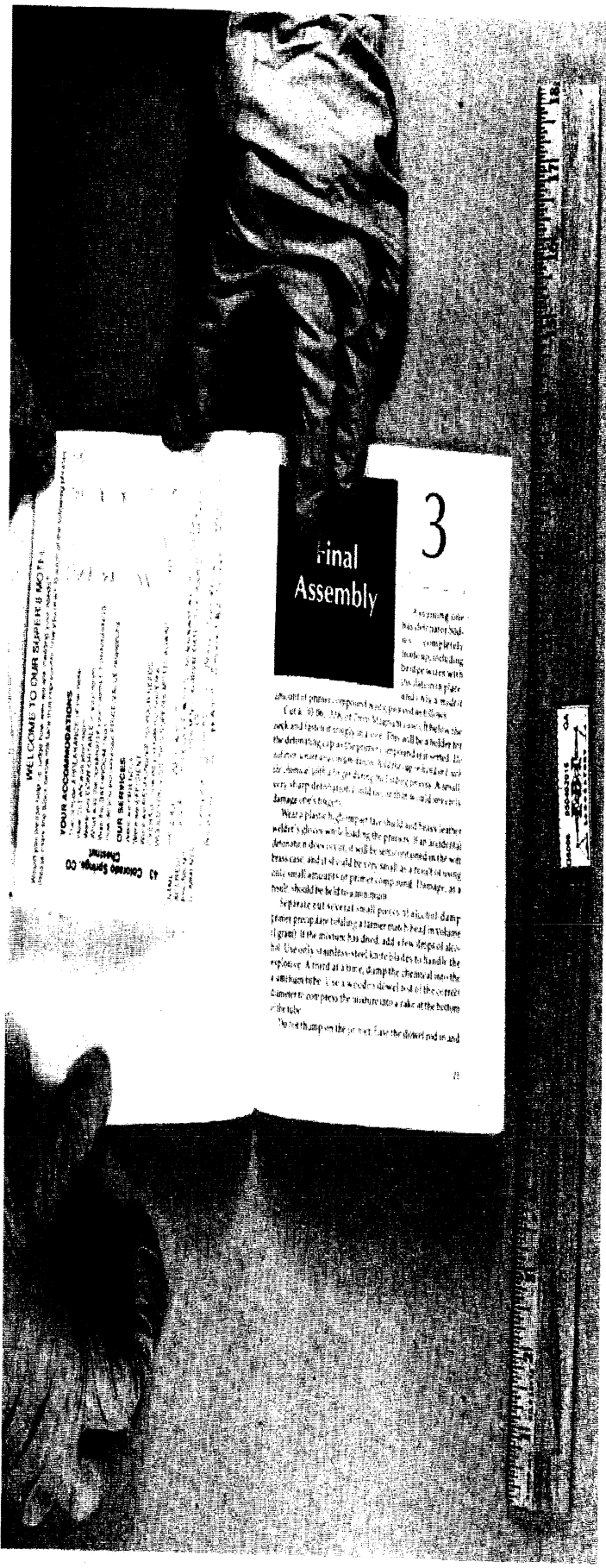

Final Assembly

Assembling the final assembly is completely straightforward with the following steps:

1. Cut a 10 lb. roll of 200 Mesh Nylon mesh below the neck and fasten snugly to a cone. This will be a holder for the deforming cap and pressure compound inserted. The solvent will cause the mesh to stretch and will not be damaged by the deforming process. A small very sharp deterioration will occur in the mesh and wear is damage one time only.

2. Wear a plastic bag over the shield and heavy leather welder's gloves while loading the pressure. If an accidental deforming does occur it will be seen on the mesh brass case and it will be very small as a result of using only small amounts of pressure compound. Damage, as a result, should be held to a minimum.

3. Separate several small pieces of standard damp proof paper by using a hammer and head in volume (gram) if the moisture has dried, add a few drops of alcohol. Use only a stainless steel knife blades to handle the response. At the end of a time, damp the chemical on the surface tube. Use a wood dowel rod of the correct diameter to compress the moisture into a rake at the bottom of the tube.

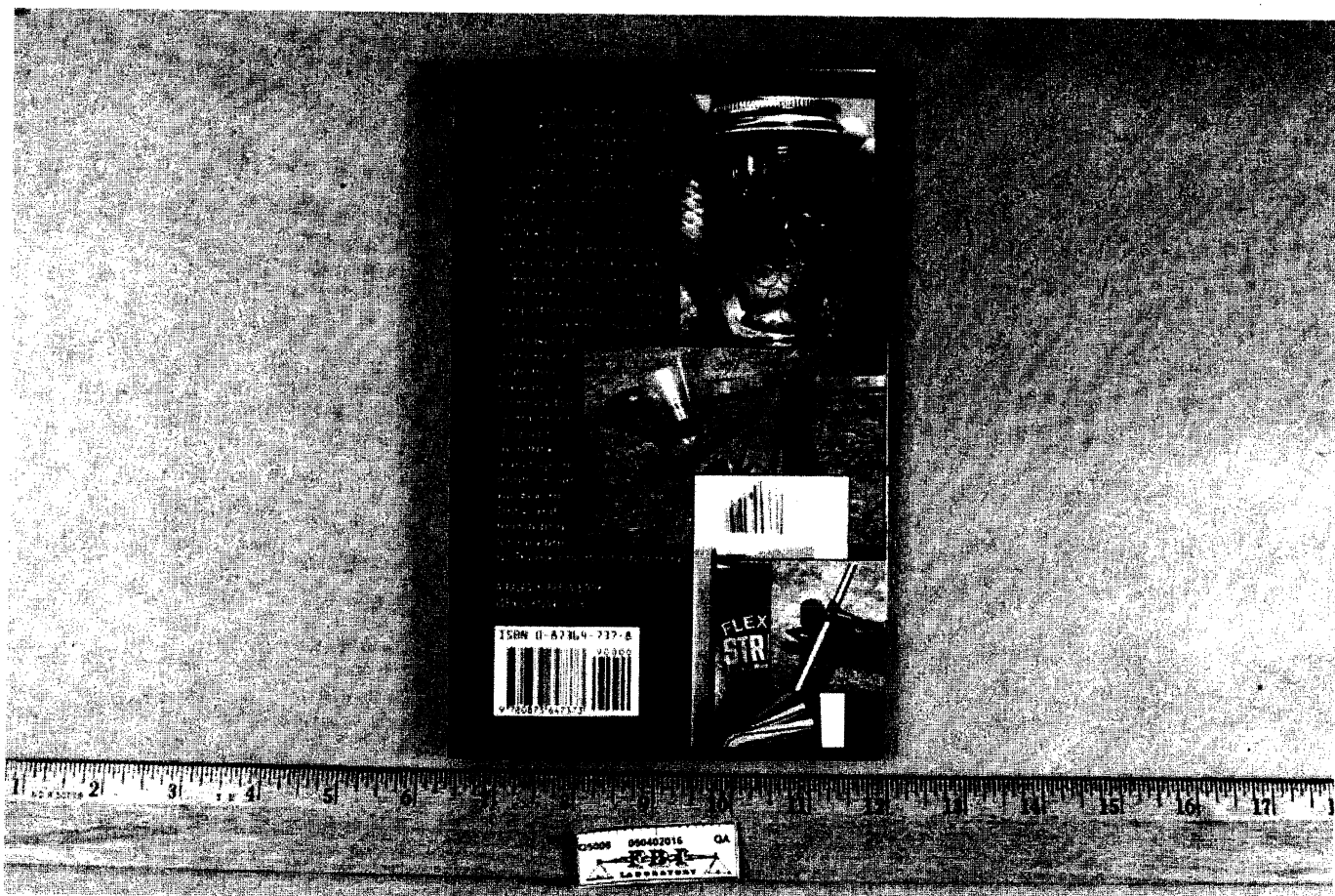
