[redacted] white male, date of birth [redacted] was contacted at his residence, for the purpose of interview. At approximately 5:50 p.m. the interviewing agents approached [redacted] in the vicinity of a large work shed, on his property, apprized him of their identities and the nature of the contact. At the outset of this contact [redacted] inquired as to whether the interviewing agents knew how to read. He then advised that the interviewing agents were trespassing. An unidentified white male (UWM), present upon the interviewing agents arrival, was directed by [redacted] to leave and return the following day.

Following the departure of the UWM, the interviewing agents advised that there were six questions that they had been directed to ask him. [redacted] advised the interviewing agents to "go ahead." Thereafter [redacted] was asked the following questions:

- 1) When was the last time you were in touch with Terry Nichols?

[redacted] responded, "Next."

- 2) When was the last time you were in Kansas City?

[redacted] responded, "Next."

- 3) When was the last time you talked to Terry's wife?

[redacted] stared at the interviewing agents. [redacted] was asked if he intended to answer this question, or any of the additional questions. [redacted] responded that he could not say inasmuch as he had not yet heard the remaining questions.

- 4) Do you have any plans to travel to Kansas City?

There was no response from [redacted]

- 5) Do you know [redacted] and if so how?

[redacted] responded, [redacted] The name was repeated and [redacted] responded, "Next."

- 6) Are you aware of any other bomb making materials that the FBI is unaware of concerning Terry, [redacted] anyone else?

[redacted] inquired, [redacted] The interviewing agents advised that the question referred to [redacted] then asked if he was aware that explosive materials had been found at [redacted] Terry's former residence. [redacted] advised that [redacted] had not lived in that house for ten years. [redacted] further stated, "This is a farce." [redacted] stated, "There's bomb making materials in here," pointing to the work shed. [redacted] advised he had diesel fuel which could be used in a bomb. He stated he may also have a bag of fertilizer.

[redacted] advised that FBI stands for "fumbling bunch of idiots. He stated that the prior searches of Terry Nichols residence must have been conducted by incompetent agents.

[redacted] asked if the interviewing agents had a tape recorder. The agents responded that they did not have a tape recorder and his comments were not being recorded on tape. [redacted] stated, "You are a bunch of liars." He asked if the interviewing agents were aware of the twenty-two video tapes that have been sealed by a court in Denver in the interest of National Security. [redacted] stated that one-hundred and sixty-eight innocent people lost their lives and the responsible parties are identified on those tapes. He questioned, "Why are they sealed?" [redacted] continued talking about the video tapes under seal in Denver.

The interviewing agents thanked [redacted] for his time and departed at approximately 6:02 p.m.
