9. DETAILS:

This is a 30 day status report in the investigation of the White Aryan Resistance and the violations of federal firearms and conspiracy laws in various counties in both the Northern and Eastern Judicial Districts of Oklahoma.

On December 9, 1994 CI-183 went to Elohim City for a three-week visit.

On December 19, 1994 this agent learned the identity of "Andy" who is said to be the head of security at Elohim City. He is actually Andreas Karl Strassmeir, a West German, DOB 051759. This agent then contacted INS in Oklahoma City and was informed that according to their records, Strassmeir is an illegal alien. Strassmeir entered the United States in May of 1991 and was scheduled to leave August of 1991, however, according to records Strassmeir has not left the country. It should be noted that Strassmeir always carries a .45 pistol.

On January 1, 1994 CI-183 returned to Tulsa. This agent received the following information:

Strassmeir is said to have worked for the C.A.U.S.E. foundation in Houston, Texas during a visit in 1987 or 1988. He also has access to prescription drugs, i.e. he maintains the "pharmacy" in which 183 viewed an ampule of xylocaine, an anesthetic. 183 watched as the xylocaine was injected into the face of a man who was having one of the women perform surgery to remove a scar he had. They told 183 the reason for the surgery was to keep the man from being identified by his scar. Zera Patterson IV told 183 that Strassmeir had questionable weapons connections. Strassmeir told 183 about a required equipment list for each resident at EC. The list

had required gear for patrols, maneuvers and combat. Each household is required to be stockpiling ammunition and it is recommended that there are 400 to 500 rounds per firearm. Each person is required to have a gas mask and spare filters. Certain individuals are trained for sniping and others are specifically trained to do combat. Strassmeir alleges that he makes weapon and firearm purchases for those who cannot buy for themselves, i.e. because of age, background, etc.

183 was not allowed to participate in the combat maneuvers, however, 183 stated that these maneuvers were taking place the day he/she arrived at EC and that the people were camping outside in 14 degree weather. 183 stated that during the maneuvers, participants were forced to swim in a creek in these frigid temperatures. The leader of these maneuvers is Strassmeir and 183 stated that he reported his dissatisfaction with his "troops" to Millar. Millar responded by calling the "troops" to stand during Sabbath meeting and yelling at them for an unsatisfactory performance.

183 met Keith Bowel, former CSA who stated that many members of CSA have stayed together and are living in Sparta, Mo. Ellison is still planning to visit EC in April and is expected to round up his followers in order to reconstruct CSA.

During the Sabbath meeting, Millar gave a sermon soliciting violence against the US Government. He brought forth his soldiers and instructed them to take whatever action necessary against the US Government. It is understood that ATF is the main enemy of the people at EC. He further stated that they would be gaining territory and expanding through the midwest. He stated that certain groups from Texas, Missouri, Arkansas and Oklahoma will be uniting as one front to fight the government. He told 183 that EC considers itself a separate nation of Israelites which happens to be located in the continental United States. He explicitly told 183 that they were preparing to fight a war against the government. He also stated that they had been close friends of the Weavers and that they agreed with what they did. He stated that they were friends with some of the Branch Dividians in Waco, Texas and that the Branch Dividians have set up another community in Colorado.

Millar has an office in his trailer and 183 noted that there are three large computer systems in this small area. Millar does not allow access to this area. It is unknown what these computers are used to do. It is expected that one use for the computers is for Millar's trucking company, RBJ Trucking, which is reported to have a garage in VanBuren, Arkansas.

183 spoke with an individual named "Mike" who is actually William Brescia and has ties to the Posse Comitatus in Pennsylvania. Mike is interested in obtaining 183's Tec-9 and stated that it is an easy firearm to convert. Zera Patterson IV told 183 that he knew that Mike would convert the firearm if 183 gave it to him.

183 met a woman named Teresa, who stated that she was a former CSA. Teresa stated that Ellison will have a militia with fully automatic firearms and that he intends to have fewer followers to insure a stronger community. 183 was told that he/she would be welcome to become part of CSA upon the return of Ellison.

183 was invited to stay at EC by Millar. 183 stated that Millar was disappointed that he/she could not stay. 183 has made many friends and has become romantically involved with one individual. 183 and this individual have formed a very close relationship and 183 has become privy to much more information based on the status of this individual. This individual stated that he/she has had a message from God to court and marry 183.

183 was able to obtain a partial telephone registry of numbers that have been called from EC. These numbers were forwarded to headquarters and the response is pending. It is known that one of the numbers belongs to Joe Cecil, who is a multiple convicted felon living in Oklahoma City, Oklahoma. This agent was contacted regarding one of the license tags on a vehicle at EC. It is owned by Robert McHenry, who is a convicted felon. He has a three year felony conviction for transporting illegal aliens.

On January 6, 1995 183 traveled to EC. 183 was allowed to move about without supervision and discovered an area in one of the metal buildings that contained reloading equipment, hundreds of shotgun shells and many boxes of shotgun primers. 183 stated that there is a huge camouflage tarp that is folded in this area and that if the tarp were to be stretched it would be the size of a giant circus tent. 183 stepped on part of the tarp and stated that there was something under it. 183 strongly suspected that the tarp was concealing some type of storage area and due to the other items found in this area, 183 believes it to be a storage for ammunition or weapons. 183 also found many boxes which contained one large screw or bolt, approx. 5 to 6 inches long and 1 1/2 to 2 inches diameter with a nut on each. It is not known what these are, however, they are scattered among the reloading equipment.

It is requested that CI 183 return to Elohim City for a three month period, which is the next step in becoming a permanent resident. 183 believes that he/she will be included in the combat maneuvers upon returning.
