This is a 30 day status report in the investigation of the White Aryan' Resistance and the violations of federal firearm, explosive and conspiracy laws in both the Northern and Eastern Judicial Districts of Oklahoma

On April 20, 1995 this agent was contacted by CI-53270-183 in regard to the bombing in Oklahoma City, Oklahoma. CI-183 stated that he/she believed suspect #2 resembled one of the residents of Elohim City, Tony Ward.

On April 21, 1995 this agent, along with Special Agent John Risenhoover, traveled to Tulsa to pick up CI-183 and transport him/her to Oklahoma City. CI-183 was debriefed by Special Agents from ATF and FBI. A lead sheet was then completed. It was then determined that CI-183 would be sent to Elohim City to obtain any intelligence relating to the bombing.

On April 29, 1995 CI-183 met with area W.A.R. leader, Dennis Mahon, and obtained several video tapes regarding the movement. CI-183 stated that they discussed alibi's for April 19, 1995 and the components of the explosive. CI-183 stated that Mahon mentioned the name of a man familiar in explosives who lives in Illinois. Mahon used the name, Pierson, however, he was not sure. CI-183 stated that Mahon could have been referring to Paulson because he cannot remember people's names.

On May 1, 1995 CI-183 traveled to Elohim City and stayed for three days.

On May 3, 1995 this agent met with CI-183 and debriefed him/her. This agent then took CI-183 to Oklahoma City to meet with ATF and FBI agents for further debriefing. CI-183 stated that while he/she was inside, a news crew was also there doing a story and that he/she was asked to stay out of

sight. CI-183 was excluded from the daily worship meetings due to the media attention. CI-183 did speak to an individual who stated, "There is a big secret out here." CI-183 also was informed by Zara Patterson IV that James Ellison was now residing at Elohim City, however, CI-183 did not see him. Ellison was the former leader of the Covenant, Sword and Arm of the Lord in Arkansas. CI-183 stated that he/she viewed the freshly dug grave of Snell, the man executed in Arkansas on April 19, 1995 for the slaying of an Arkansas trooper. CI-183 was informed that Robert Millar had attended the execution and transported the body to his compound for burial. CI-183 stated that individuals spoken with were supportive of the bombing of the building in Oklahoma City.

On May 18, 1995 this agent met with CI-183 to discuss returning to Elohim City in order to determine what the "big secret" is and to attempt to identify suspect #2.

On May 22, 1995 this agent was contacted by CI-183 who stated that he/she had been contacted the previous day and informed that he/she had better not go to Elohim City. CI-183 stated that the person called again on this day and gave him/her the same warning. CI-183 did not reveal the source at this time. CI-183 then stated that he/she had seen the numerous television broadcasts about Elohim City and was too frightened to go.

On May 24, 1995 this agent was informed by RAC, David Roberts that Robert Millar suspected CI-183 of being a confidential informant. It was determined that CI-183 would not be sent to Elohim City at this time or in the future.
